Rd.; thence along the East line of said Co. Rd. N 15° 24' 20" E 70.00 feet to an iron pin (set) at the Southwest corner of said parcel no. 1; thence along the South line of said Parcel no. 1 S 84° 44' 26" E 286.97 feet to the place of beginning containing 0.460 acres.

The bearings within this description are based on the center line of said abandoned road as described in deed reference Vol. 530, Page 494 which was surveyed by Karl C. Mawhorter R.S. #4511. The iron pins (set) are 5/8' rebars 34" in length with aluminum identification caps ( C.R. Harkness R.S. 6885 ).

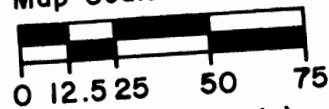

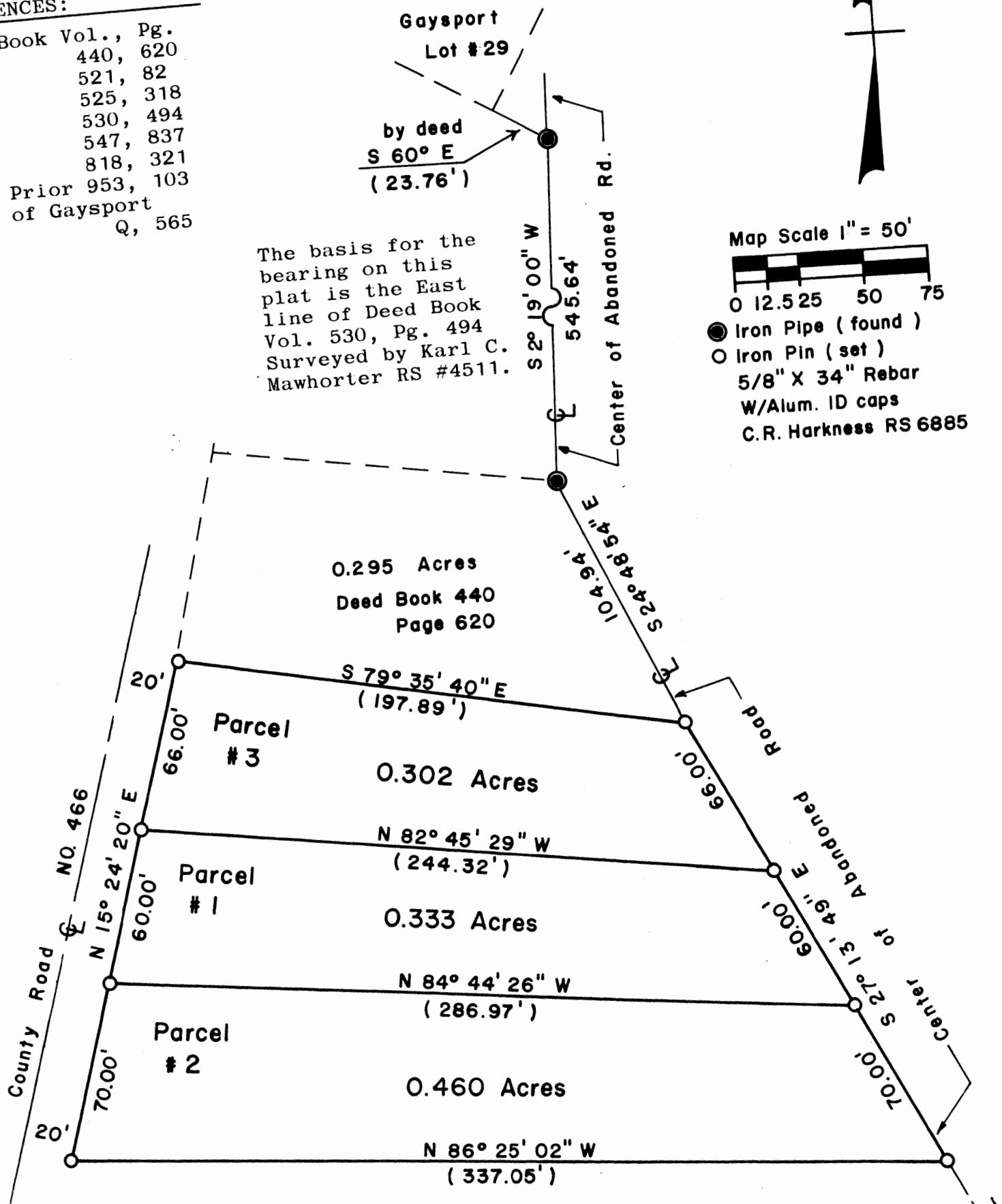
