Description of Parcel

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, being part of the southeast quarter of Section 20, Range 12 West, Township 12 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for Reference at an iron pin set at the southeast corner of Section 20;

thence, with the south line of Section 20, South  $88^{\circ}31'29''$  West a distance of 714.03 feet to an iron pin set at the southeast corner of a 16.26 acres tract as conveyed to Maxine Brock by Deed Volume 712, Page 48 of the Muskingum County Recorder's Office;

thence, leaving the section line and running with the east and north lines of said Brock property, the following two courses:

- (1) North  $20^{\circ}57'12''$  West a distance of 407.22 feet to an iron pin set;
- (2) thence North  $82^{\circ}13'59''$  West a distance of 1,069.41 feet to a point in the centerline of County Road No. 466, passing through an iron pin set at a distance of plus 1,049.88 feet, said point in the centerline of County Road No. 466 being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning leaving the road, North  $82^{\circ}13'59''$  West a distance of 144.99 feet to an iron pin set at the northwest corner of said Brock property at an angle point in the west line of lot 3 of a plat recorded in Deed Volume 680, Page 296 of the Muskingum County Recorder's Office;

thence, with the west line of lots 3, 2, and 1, North  $40^{\circ}17'32''$  East a distance of 382.80 feet to an iron pin set, passing over the northeast corner of said Lot 3 at a distance of plus 29.22 feet;

thence, with the east line of three unrecorded lots, the following two courses:

- (1) North  $23^{\circ}47'32''$  East a distance of 151.80 feet to an iron pin set;
- (2) thence North  $16^{\circ}32'33''$  East a distance of 110.52 feet to a point;

thence North  $46^{\circ}27'26''$  East a distance of 25.89 feet to a point in the centerline of County Road No. 466;

thence, with the centerline of County Road No. 466, the following fourteen courses:

- (1) South  $07^{\circ}36'30''$  East a distance of 39.29 feet to a point;

- (5) thence South 28°15'00" East a distance of 96.00 feet to a point;
- (6) thence South 27°00'00" West a distance of 90.00 feet to a point;
- (7) thence South 69°00'00" West a distance of 120.00 feet to a point at the southeast corner of said 1.398 acres tract;
- (8) thence South 75°00'54" West a distance of 73.84 feet to a point;
- (9) thence South 66°46'43" West a distance of 74.73 feet to a point;
- (10) thence South 49°03'51" West a distance of 43.06 feet to a point;
- (11) thence South 38°02'38" West a distance of 29.60 feet to a point;

- (14) thence South 04°50'48" West a distance of 40.49 feet to the Point of Beginning;
