## Description of Parcel 1

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, being part of the southeast quarter of Section 20, Range 12 West, Township 12 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for Reference at an iron pin set at the southeast corner of Section 20:

thence, with the south line of Section 20, South 88\*31'29" West a distance of 714.03 feet to an iron pin set at the southeast corner of a 16.26 acres tract as conveyed to Maxine Brock by Deed Volume 712, Page 48 of the Muskingum County Recorder's Office;

thence, leaving the section line and running with the east line of said Brock property, North 20057'12" West a distance of 407.22 feet to an iron pin set, being <u>THE TRUE POINT OF BEGINNING</u> for this description;

thence, from said Point of Beginning with the north line of said Brock property , North 82°13'59" West a distance of 1,069.41 feet to a point in the centerline of County Road No. 466, passing through an iron pin set at a distance of plus 1,049.88 feet,

thence, with the centerline of County Road No. 466, the following seven courses:


- (1) North 04.º50'48" East a distance of 40.49 feet to a point;
