DESCRIPTION OF PART OF PARCEL # 06 - 44 - 03 - ~~18~~ WHICH WAS CONVEYED TO
DAVID AND CRYSTAL BROCK IN VOLUME 1008, PAGE 403 OF MUSKINGUM RECORDS.

Situate in the State of Ohio, County of Muskingum, Township of Blue Rock, and being a part of the Southeast Quarter of Fractional Section # 20, Township 12 North, Range 12 West, in the Congress Lands East of the Scioto River and being part of parcel # 06 - 44 - 03 - 31 as conveyed to David and Crystal Brock in Deed Volume 1008, Page 403, of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning for reference at a point at the Southeast corner of Fractional Section # 20, Township 12 North, Range 12 West, in the Congress Lands East of the Scioto River, thence South 88 degrees 31 minutes 29 seconds West 714.03 feet to a point at the Southeast corner of David and Crystal Brock property; thence along the south line of said Brock property and the North line of T. Fleming (Vol. 1070 Pg. 472), South 88 degrees 32 minutes 48 seconds West 321.06 feet to an iron pin set and the True Place of Beginning; thence along the south line of said Brock property South 88 degrees 32 minutes 48 seconds West 1247.92 feet to a point in the centerline of Gaysport Hill Road (County Road # 466), passing an iron pin found at 932.95 feet and 1223.15 feet; thence along said centerline, North 33 degrees 36 minutes 11 seconds East 224.84 feet to a point in said centerline; thence along a new line crossing said Brock property, North 88 degrees 32 minutes 48 seconds East 1118.79 feet to an iron pin set, passing an iron pin set at 28.33 feet; thence on a new line South 01 degrees 27 minutes 05 seconds East 184.05 feet to an iron pin set at the True Place of Beginning.

Containing 5.000 Acres, more or less, subject to all easements, restrictions, or right of ways, either written or implied. All iron pins set are 30 inch long by 5/8 inch diameter rebar with a yellow cap labeled "BINCKLEY S-7879".

Bearings contained herein are assumed from a previous survey by S. M. Bowman dated 8 - 10 - 1994 of the south line of Fractional Section # 20 as being South 88 degrees 32 minutes 48 seconds West and are for angular measurement only.

This description is based on a field survey made by Binckley Land Surveying, Nashport, Ohio in May 1999.

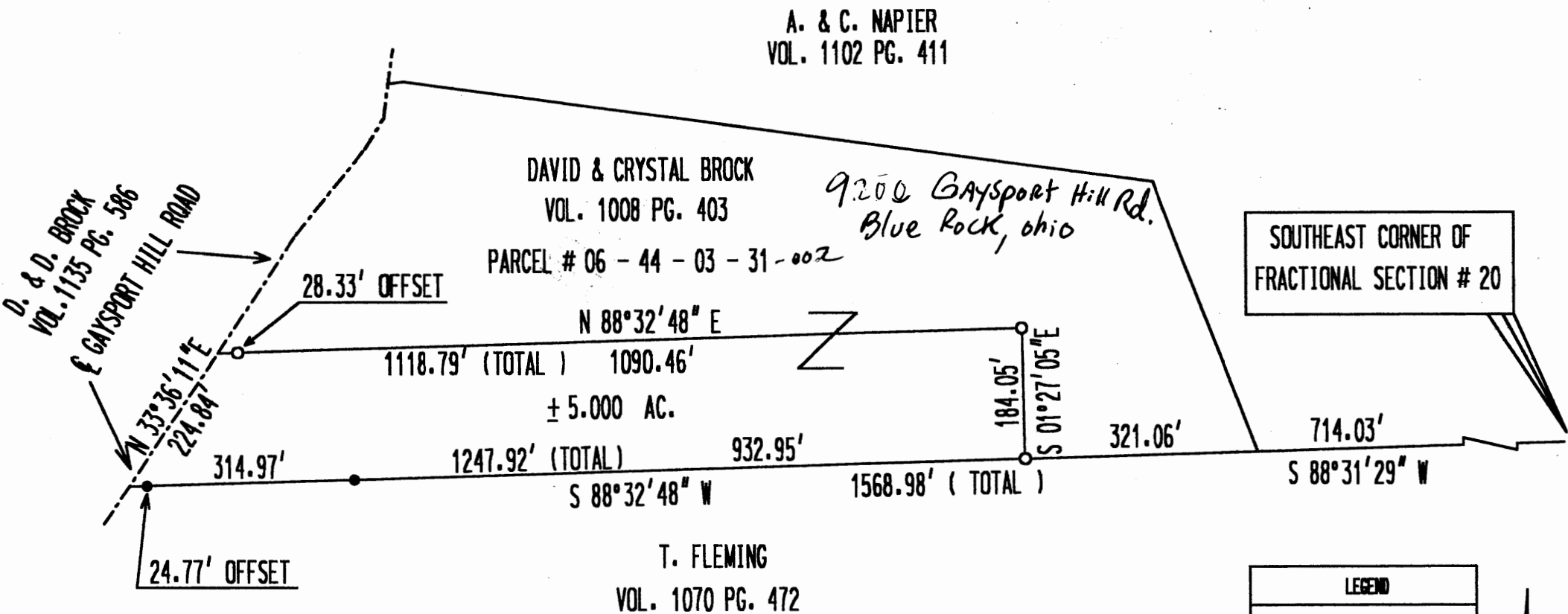
