Legal Description Tract 2: 6.120 Acres

Part Countrytyme Land Specialists, Ltd. Parcel: O.R. Book 3054, Page 809

Situated in the Township of Blue Rock, County of Muskingum, State of Ohio, and being a part of the Southeast Quarter of Section 16, Township 12N, Range 12W, of the Congress Lands, and being more particularly described as follows;

Being a Survey of a part of a 13.802 Acre parcel conveyed to Countrytyme Land Specialists, Ltd., as recorded in O.R. Book 3054, Page 809, in the Muskingum County Deed Records, being part of Auditor's P.P.N. 06-50-16-20-004, and further described as follows;

Commencing at Railroad spike set in the centerline of Shaver Road (T.R. 227) marking the Southwest corner of said 13.802 Acre parcel Countrytyme Land Specialists, Ltd., of which this description is a part, also being the Southeast corner of a 5.924 Acre parcel conveyed to Chauntelle Fleming, as recorded in O.R. Book 1118, Page 225: said spike bears N 51°30'25" E 2143.94 feet from the Southwest corner of the Southeast Quarter of Section 16;

Thence, S 59°34'48" E 137.85 feet with the centerline of Shaver Road and the South line of said parcel conveyed to Countrytyme Land Specialists, Ltd., of which this description is a part, to a point marking the <u>PRINCIPAL PLACE OF BEGINNING</u> of the 6.120 Acre parcel herein to be described;

Thence, N 36°58'59" E 564.53 feet leaving Shaver Road with a line across said parcel conveyed to Countrytyme Land Specialists, Ltd., of which this description is a part, to a concrete monument found on the West line of a parcel conveyed to The State of Ohio, as recorded in Deed Volume 479, Page 53, passing over an iron pin set at 30.00 feet, and passing over the centerline of Poverty Ridge Road at 387.33 feet;

Thence with the East line of said parcel conveyed to Countrytyme Land Specialists, Ltd., of which this description is a part, the same being the West line of said parcel conveyed to The State of Ohio, with the following three (3) courses and distances:

- 1) S 30°59'57" E 152.28 feet to a concrete monument found;
- 2) S 47°22'04" E 175.77 feet to a concrete monument found;
- 3) S 62°07'22" E 263.00 feet to a concrete monument found on West line of a 41.70 Acre parcel conveyed to Jeffrey E. Shook, Jr., ETAL, as recorded in O.R. Book 1640, Page 105;

Thence, S 03°19'17" E 235.77 feet with the East line of said parcel conveyed to Countrytyme Land Specialists, Ltd., of which this description is a part, the same being the West line of said parcel conveyed to Shook, ETAL, to an iron pin set in the centerline of said Shaver Road;

Thence with the South line of said parcel conveyed to Countrytyme Land Specialists, Ltd., of which this description is a part, the same being the centerline of Shaver Road, with the following four (4) courses and distances:

- 1) N 86°01'48" W 242.82 feet to a point;
- 2) N 88°35'48" W 252.70 feet to a point;
- 3) N 74°31'48" W 138.25 feet to a point;
- 4) N 59°34'48" W 191.78 feet to the PRINCIPAL PLACE OF BEGINNING.

Said parcel as surveyed contains 6.120 Acres, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The bearings of the above description are based on the West line of a 13.802 Acre parcel conveyed to Countrytyme Land Specialists, Ltd., as recorded in O.R. Book 3054, Page 809, in the Muskingum County Deed Records, as being N 01°20'16" E, and is an assumed Meridian used to denote angles only.

All iron pins set are 5/8" o.d. iron pins 30" long with red caps labeled "S.A. ENGLAND #S-7452".
