LEGAL DESCRIPTION FOR R. RILEY, ET AL

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF BLUE ROCK, AND BEING PART OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 21, TOWNSHIP 12, RANGE 12, AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 1032, PAGE 399; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 21, THENCE, NORTH 89 DEGREES - 32 MINUTES - 01 SECONDS EAST, 221.26 FEET TO A POINT IN THE CENTER OF STATE ROUTE 376, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, NORTH 71 DEGREES - 09 MINUTES - 03 SECONDS WEST, 18.61 FEET ALONG SAID CENTERLINE TO A POINT; THENCE, NORTH 04 DEGREES - 50 MINUTES - 55 SECONDS EAST, 397.96 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 33.00 FEET; THENCE, NORTH 71 DEGREES - 52 MINUTES - 51 SECONDS EAST, 1107.20 FEET TO AN IRON PIN SET ON THE EAST LINE OF THOSE LANDS DESCRIBED IN SAID DEED VOLUME 1032, PAGE 399; THENCE, SOUTH 00 DEGREES - 46 MINUTES - 20 SECONDS EAST, 738.17 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 89 DEGREES - 32 MINUTES - 01 SECONDS WEST, 1078.30 FEET TO THE POINT OF BEGINNING, PASSING IRON PINS FOUND AT 525.73 FEET AND 903.96 FEET, AND CONTAINING 14.018 ACRES MORE OR LESS.




