Book 2004, Page 99 of the Muskingum County Deed Records bounded and described as
follows:

Commencing at an iron pin found at the southeast corner of said southwest
quarter of section 21; thence N 87°27'26''W (the base of bearings is state plane grid
from a solar observation) along the south line of said southwest quarter a distance of
1293.44 feet to an iron pin found at the southeast corner of a 10.00 acre parcel (Vol.
2004, Pg. 99) and the true place of beginning for the following described parcel; thence
N 87°25'02''W along the south line of said southwest quarter of section 21 and along the
north line of property owned by Donald and Alma French (Vol. 1149, Pg. 421) a
distance of 462.92 feet to an iron pin found; thence along the east line of a land contract
from Robert E. and Mary M. Fox to Cecil T. and Patricia A. Jewett (Vol. 1279, Pg. 205)
the following 2 courses and distances:

1- N 26°34'31''E 513.44 feet to an iron pin found
2- N 26°26'29''E 307.25 feet to a point in the center of State Route 376 (Rockville Road)
and passing through an iron pin found at 282.25 feet; thence along the center of said road
and along the south line of property owned by Rodney Shook (Vol. 1007, Pg. 37) the
following 3 courses and distances:

1- S 55°15'08''E 64.83 feet to a point
2- S 53°17'17''E 36.98 feet to a point
3- S 49°25'23''E 60.39 feet to a point on the east line of the aforesaid 10.00 acre parcel
(Vol. 2004, Pg. 99); thence S 2°51'44''W along the east line of said 10.00 acres (Vol.
2004, Pg. 99) and the west line of Mary M. Fox Estate (Vol. 2004, Pg. 90) 478.08 feet
to a 2 1/2' x 3' pipe found at the northwest corner of property owned by Elizabeth S. Gay
(Vol. 2004, Pg. 196); thence continuing S 2°51'44''W along the east line of said 10.00
acre parcel and the west line of said Gay property 179.56 feet to the true place of
beginning containing 5.00 acres.

easements on record.




BASE OF BEARINGS IS STATE PLANE GRID


