

## Description of Parcel 13-A

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, being in the southwest quarter of Section 21, Range 12 West, Township 12 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for Reference at an iron pin set at the southwest corner of Section 21;

thence, with the south line of Section 21, North 88°55'08" East a distance of 459.25 feet to an iron pin set being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning leaving the section line, North 32°52'11" East a distance of 1,008.10 feet to a point in the centerline of State Route 376, passing through two iron pins set at distances of plus 749.98 feet and plus 988.10 feet, respectively;

thence, with the grantor's north property line being with the centerline of State Route 376, South 58°51'39" East a distance of 160.00 feet to a point;

thence, leaving the road, South 22°49'59" West a distance of 821.45 feet to an iron pin set in the south line of Section 21, passing through two iron pins set at distances of plus 25.00 feet and plus 125.00 feet, respectively;

thence, with the south line of Section 21, South 88°55'08" West a distance of 365.38 feet to the Point of Beginning;

containing 5.000 acres, more or less, being a new split out of Parcel No. 06-06-50-21-26-002.

Subject to all legal right-of-ways, easements, restrictions, reservations, and zoning regulations of record.

Subject to any facts that may be disclosed by a full and accurate title search.

Subject to a 40.00 feet wide easement being reserved unto the grantor, his heirs, and/or assigns, forever. Said easement is for the purposes of running utilities to other parcels of land on or near State Route 376. Said easement runs in an east-west direction across the north end of the above described property with the north line of said easement being the centerline of State Route 376. Containing 0.147 acres, more or less, of easement.
