

## Description of Parcel 8

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, being in the northeast quarter of Section 16, Range 12 West, Township 12 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for reference at a point at the northeast corner of Section 16 (Note: Said point is located for reference North  $02^{\circ}41'28''$  West along the east line of Section 16 a distance of 5.00 feet from an iron pin found labeled "Biedenbach PS-5718, PS-6923" );

thence, with the north line of Section 16, South  $84^{\circ}32'37''$  West a distance of 757.99 feet to a point;

thence, leaving the section line, South  $04^{\circ}03'22''$  West a distance of 503.59 feet to a point in the centerline of Township Road No. 234, said point being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning with the centerline of Township Road No. 234, South  $62^{\circ}27'53''$  East a distance of 90.22 feet to a point;

thence, leaving the road, South  $26^{\circ}29'24''$  West a distance of 1,205.91 feet to an iron pin set, passing through two iron pins set at distances of plus 15.00 feet and plus 115.00 feet, respectively;

thence South  $88^{\circ}21'57''$  West a distance of 330.00 feet to an iron pin set;

thence North  $30^{\circ}33'04''$  East a distance of 1,368.44 feet to a point in the centerline of Township Road No. 234, passing through two iron pins set at distances of plus 1,253.44 feet and plus 1,353.44 feet, respectively;

thence, with the centerline of Township Road No. 234, South  $62^{\circ}27'53''$  East a distance of 103.94 feet to the Point of Beginning;

containing 7.074 acres, more or less.

Subject to all legal right-of-ways, easements, restrictions, reservations, and zoning regulations of record.

Subject to a 30.00 feet wide easement being reserved unto the grantor, his heirs, and/or assigns, forever. Said easement is for the purposes of running utilities to other parcels of land on or near Township Road No. 234. The north line of said easement being the centerline of Township Road No. 234. Containing 0.134 acres, more or less, of easement.

All iron pins set are rebar with yellow caps labeled "Claus 6456".

The bearings in this description are for angle calculations only and are based on the north line of Section 16 being North 86°48'59" East as shown on a survey by R.M. Roberts, Registered Surveyor No. 5803, dated July 6, 1973, and on the bearings found in Deed Volume 718, Page 337 of the Muskingum County Recorder's Office.
