

Paul & David Abele OR 1761-208 +/- 0.652 Ac.

Being a part of the Southwest Quarter of Sec. 14, Township 12, Range 12, Blue Rock Township, Muskingum County, also being part of the lands now owned by Paul & David Abele, OR 1761-208, Parcel Number 06-60-14-05-000 more fully described as follows.

Beginning for reference at a concrete monument found at the northeast corner of the southwest quarter of Section 14, also being in the northwest corner of the lands now owned by Paul & David Abele (OR 1761-208, Parcel No.: 06-60-14-08-000), thence with the west line of said Abele's lands, South 02 degrees 16 minutes 35 seconds West, 438.60 feet to an iron pin found;

thence continuing with said west line of Abele's lands, south 02 degrees 26 minutes 05 seconds West, 537.27 feet to an iron pin found and the principal place of beginning;

thence with the common line of Paul & David Abele's parcels 06-60-14-08-000 and 06-60-14-05-000, South 02 degrees 10 minutes 04 seconds West, 112.26 feet to a point in the center of a stream, passing an iron pin set at 98.05 feet;

thence leaving said common line and going through said parcel no.: 06-60-14-05-000 with the center of said stream the following 6 courses:

- 1. North 72 degrees 00 minutes 50 seconds West, 36.54 feet to a point;
- 2. North 83 degrees 06 minutes 41 seconds West, 52.71 feet to a point
- 3. North 82 degrees 11 minutes 28 seconds West, 46.57 feet to a point;
- 4. South 79 degrees 48 minutes 01 seconds West, 76.52 feet to a point;
- 5. South 71 degrees 23 minutes 39 seconds West, 49.02 feet to a point;
- 6. South 40 degrees 21 minutes 14 seconds West, 74.43 feet to a railroad spike set in the cent of Cutler Lake Road (CR-45);
- 7. thence with the center of said Cutler Lake Road, North 16 degrees 50 minutes 35 seconds West, 131.42 feet to a point on the southwest corner of the lands now owned by Paul R. & Sue A. Abele (DR 1129-282);

thence leaving said center of Cutler Lake Road and with the south line of said Paul and Sue Abele's lands North 82 degrees 01 minutes 43 seconds East, 348.89 feet to the point of beginning, passing an iron pin found at 17.41 feet, containing 0.652 acres more or less, subject to all legal highways and easements of record.




