Wilson and Recorded in Deed Book 783, Page 41 of the Muskingum County Deed Records bounded and described as follows:

Commencing at an iron pin set at the southeast corner of said southeast quarter of section 14, thence north 86 degrees 47 minutes 53 seconds west (the base of bearings for this description true north by sun hour angle method) along the south line of said section 14 a distance of 798.94 feet to a point; thence north 3 degrees 12 minutes 07 seconds east 469.29 feet to a railroad spike set in the center of Cutler Lake Road at the true place of beginning for the following description; thence north 83 degrees 55 minutes 44 seconds west along the center of said road 121.82 feet to a railroad spike set; thence north 19 degrees 04 minutes 16 seconds east 197.19 feet to an iron pin set and passing through an iron pin set at 30.00 feet; thence south 70 degrees 55 minutes 44 seconds east 118.70 feet to an iron pin set; thence south 19 degrees 04 minutes 16 seconds west 169.79 feet to the true place of beginning and passing through an iron pin set at 139.40 feet containing Fifty hundredths (0.50) of an acre more or less

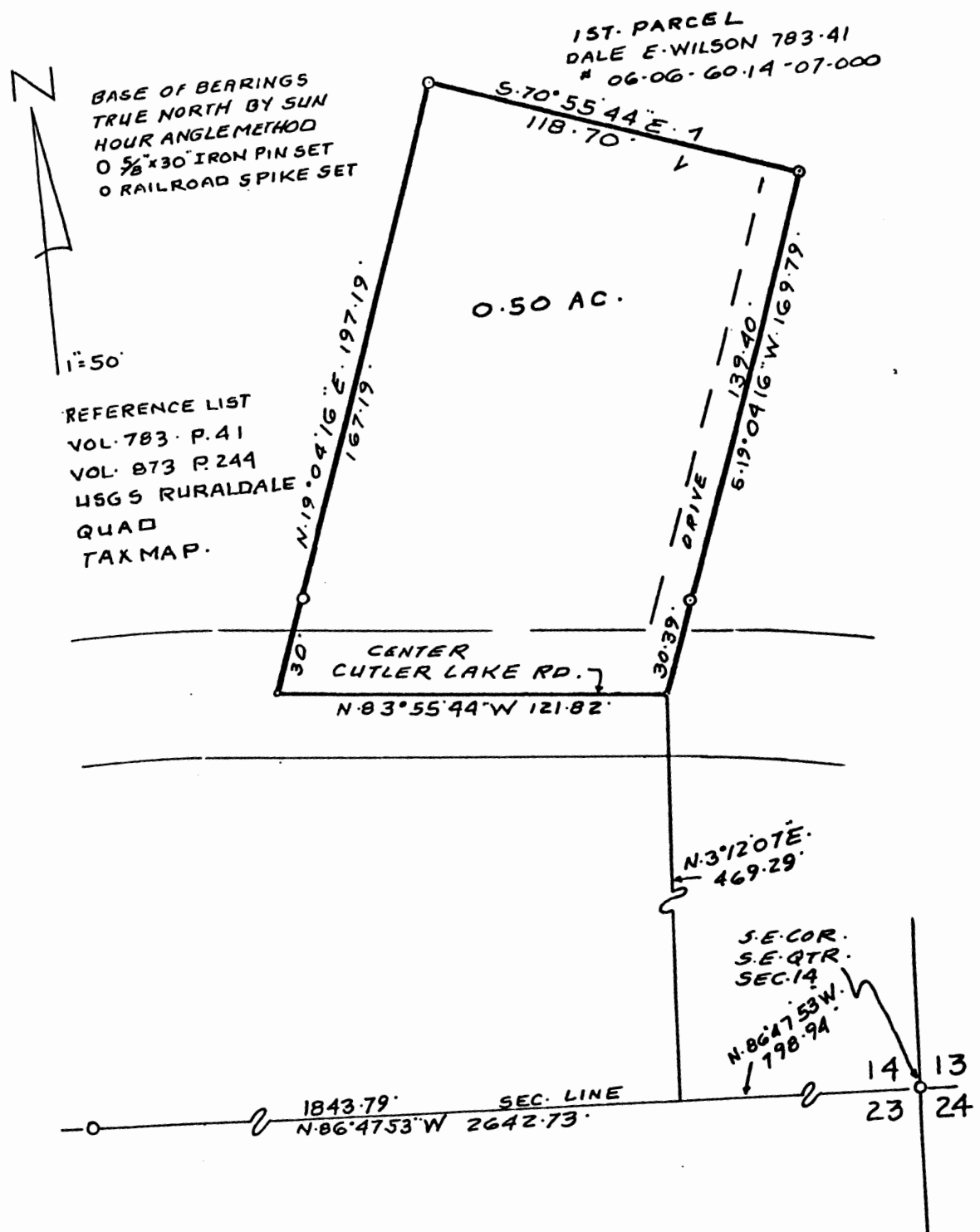
