

DESCRIPTION OF SURVEY FOR ADDA WILLIAMSON

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, Southeast Quarter of Section #32, Township #12, Range #12, of the Congress Lands East of the Scioto River:

Being a part of the prior deed reference Volume 1000, Page 489 as recorded in said county's deed records, also being a part of the Muskingum County Auditor's Parcel Number 06-06-70-32-13-002, and more particularly described as follows;

Commencing at the intersection of the center line of State Route #60 (South River Road) and the South line of said Section #32 also being the line between Muskingum and Morgan Counties; thence along the center line of said State Route 60 as shown on the right of way plans section G in January 1930 the following four courses-

- #1- along a curve to the left having a Radius of 1909.86 feet, a Arc length of 467.79 feet, and a Chord bearing N 11 12 07 W 466.62 feet;
- #2- N 18 13 08 W 285.17 feet;
- #3- along a curve to the right having a Radius of 5729.58 feet, a Arc length of 366.67 feet, and a Chord bearing N 16 23 08 W 366.60 feet;
- #4- N 14 33 08 W 367.62 feet to the center of a large concrete box culvert and the place of beginning for the property herein intended to be described;

thence along the center of an unnamed tributary of the Muskingum River S 39 53 06 W 123.96 feet to the extended low-water-mark of said river; thence along said low-water-mark N 06 58 02 W 106.51 feet; from which an iron pin (set) for reference bears N 78 59 19 E 12.00 feet; thence continuing along said low-water-mark N 14 42 59 W 99.87 feet to the Southwest corner of the property described in deed reference Volume 525, Page 526; thence along and extending the East line of said Volume 525, Page 526 N 70 34 52 E 88.31 feet to the center of said State Route #60, passing axles (found) at 8.00 feet and at 48.18 feet; thence along the center of said State Route #60 S 14 10 31 E 140.85 feet to the place of beginning containing 0.352 acres.

The bearings within this description are based on a Solar Observation (Local Hour Angle Method) completed on the property. Iron pins (set) are 5/8" rebar with aluminum identification caps (C R Harkness R S 6885).

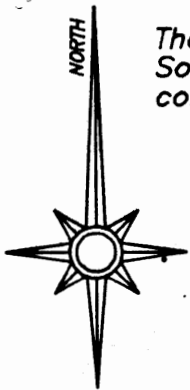

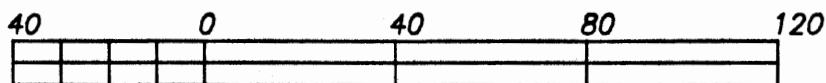

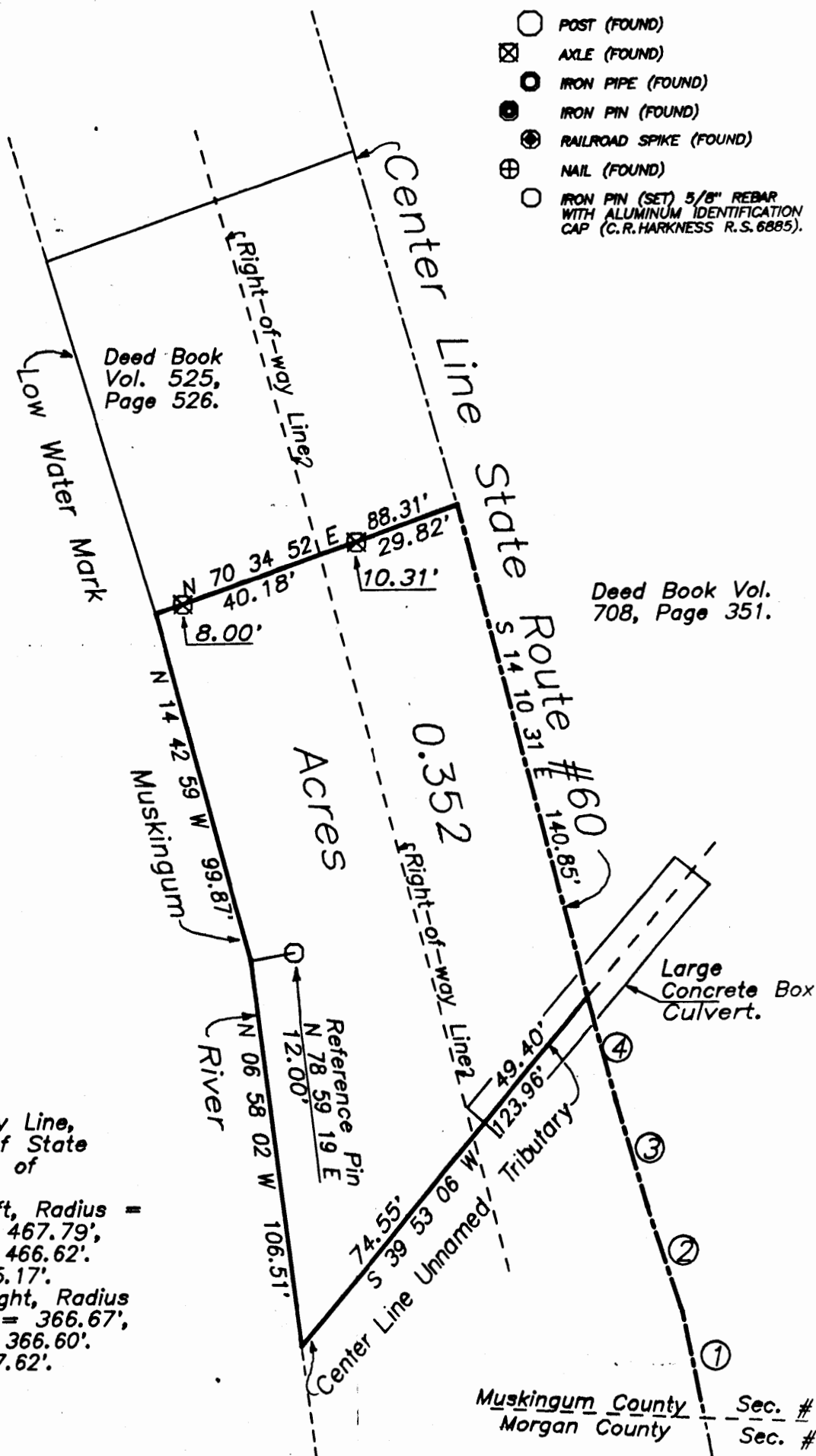
Calls for Tie, from the Muskingum-Morgan County Line, along the Center line of State Route #60, to the Place of Beginning.
