DESCRIPTION OF SURVEY FOR Paul L. & Lillian A Corbett

Situated in the State of Ohio, County of Muskingum, Township of Blue Rock, Southeast Quarter of Section #32, Township #12, Range #12 of the Congress Lands East of the Scioto River, and more particularly described as follows:

Being all of the property described in the prior deed reference Vol. 525, Page 526, which is Muskingum County Auditor's parcel #06-06-70-32-18-000.

Commencing at the intersection of the center line of State Route #60 as shown on the right-of-way plans section G in January 1930, with the South line of said Section #32; thence along the center line of said State Route #60 as shown on said plans the following four courses -

- #1- along a curve to the left having a Radius of 1909.86 feet, a Curve length of 467.74 feet and a Chord bearing N 8° 16' 59" W 466.62 feet to the PT of said curve;
- #2- N 15° 18' W 285.17 feet to the PC of a curve;
- #3- along said curve to the right having a Radius of 5,729.58 feet, a Curve length of 366.67 feet, and a Chord bearing N 13^o 28' W 366.60 feet to the PT of said curve;
- #4- N 11^o 38' W 367.62 feet to the center of a large concrete box culvert; thence along the center line of the existing State Route #60 N 110 15' 23" W 140.85 feet; thence S 73° 30'00" W 40.13 feet to an iron pin (set) on the West right-of-way of said State Route #60, being the place of beginning for the property herein intended to be described, passing an axle (found) at 29.82 feet; thence S 73° 30' 00" W 48.18 feet to the low water mark of the Muskingum River, passing an axle (found) at 40.18 feet; thence along said low water mark N 13° 54' 25" W 101.21 feet; thence N 73° 30' 00" E 49.80 feet to an iron pin (set) on the said right-of-way, passing an iron pin (set) at 11.00 feet; thence along said right-of-way S 12° 59' 30" E 101.30 feet to the place of beginning containing 0.114 acres.
