Situated in the County of Muskingum, State of Ohio and Township of Blue Rock and bounded and described as follows:


Being a part of the Northeast Quarter of Section 28 of Township 12 in the 12th Range, Blue Rock Township, Muskingum County, Ohio and being further described as follows:

Commencing at an iron pin marking the Northwest corner of a 0.52 acre tract owned by Delma Jackson, recorded in Volume 588 at Page 49 of the Muskingum County Deed Records; thence along the West line of said tract, South 1 degrees, 33 minutes, 20 seconds East 220.73 feet (Deed bearing being South 9 degrees, 02 minutes West) to a point on the North line of a 120 acre tract (recorded in Volume 611 at Page 110 of the Muskingum County Deed Records) and in the center of State Route 376; thence along the North line of said 120 acre tract, North 86 degrees, 58 minutes, 40 seconds West 206.70 feet to a point in the center of State Route 376, said point being the place of beginning of this tract; thence continuing North 86 degrees, 58 minutes, 40 seconds West 100.0 feet along the North line of said 120 acre tract to a point in the center of State Route 376; thence North 3 degrees, 04 minutes East 355.87 feet to a point marked by an iron pin, passing an iron pin at 25.0 feet; thence South 83 degrees, 55 minutes, 15 seconds East 100.0 feet to a point marked by an iron pin; thence South 3 degrees, 02 minutes, 42 seconds West 350.55 feet to the place of beginning, passing an iron pin at 325.55 feet, containing 0.8103 acres, subject to all legal road right-of-way.


