Being part of Section 35, Township 12, Range 12, of the Congress Lands East of the Scioto River, being all of the Trustees of the Rockville Baptist Church property recorded in Deed Book Volume 10, Page 402 of said county's deed records, known as the Ruraldale Cemetery, further being all of Muskingum County Auditor's Parcel Number 06-90-35-12-000, and more particularly described as follows;

Commencing at an iron pin (set) at the common corner for Sections 25, 26, 35, and 36 of Blue Rock Township;

TIE-1 THENCE North 87 degrees 25 minutes 57 seconds West 2527.62 feet along the common line for Sections 26 and 35, further being a common line for the Ohio Franklin Realty, LLC property recorded in Official Record Volume 2594, Page 344 and for the Jodie T Ashton and Jerrald Frederick Woodard Jr. property recorded in Official Record Volume 1901, Page 561 to an unmarked point in the centerline of Rockville Road (State Route 376), passing an iron pin (set) at 2502.38 feet;

TIE-2 THENCE South 33 degrees 38 minutes 08 seconds East 100.00 feet into Section 35, along said road, and through said Ohio Franklin Realty, LLC property

to an unmarked point;

TIE-3 THENCE South 34 degrees 36 minutes 00 seconds East 100.01 feet continuing along said road and through said property to an unmarked point;

TIE-4 THENCE South 34 degrees 58 minutes 52 seconds East 142.61 feet continuing

along said road and through said property to an unmarked point;

TIE-5 THENCE with a curve to the left having, a chord bearing South 40 degrees 40 minutes 07 seconds East 114.45 feet, a radius of 577.40 feet, and arc length of 114.64 feet, continuing along said road and through said property to an unmarked intersection with Ruraldale Cemetery Road;

TIE-6 THENCE with a curve to the left having, a chord bearing South 27 degrees 30 minutes 41 seconds East 116.25 feet, a radius of 162.79 feet, and arc length of 118.87 feet, along Ruraldale Cemetery Road and continuing through said property to the unmarked place of beginning for the property herein intended to be described;

THENCE with a curve to the left having, a chord bearing South 53 degrees 01 #1minutes 41 seconds East 95.77 feet, a radius of 300.00 feet, and arc length of 96.18 feet continuing along said road and Cemetery property to an unmarked

THENCE South 62 degrees 12 minutes 57 seconds East 63.57 feet continuing #2-

along said road and Cemetery property to an unmarked point; THENCE South 32 degrees 36 minutes 49 seconds West 243.47 feet leaving #3said road and continuing along said Cemetery property to an iron pin (set), passing an iron pin (set) at 11.10 feet;

THENČE North 64 degrees 05 minutes 56 seconds West 73.15 feet continuing #4-

along said Cemetery property to an iron pin (set);

THENCE North 13 degrees 51 minutes 57 seconds East 268.18 feet continuing #5along said Cemetery property to the place of beginning, passing an iron pin (set) at 252.04 feet containing 0.65 acres, of which 0.07 acres are within the right of way for Ruraldale Cemetery Road.
