Parcel One:

Beginning at a stone found at the southwest corner of the southeast quarter of Section 15; thence north 2 degrees 29 minutes 54 seconds east 280.50 feet to an iron pin found; thence north 89 degrees 00 minutes 34 seconds east 1328.41 feet to an iron pin found; thence south 5 degrees 07 minutes 29 seconds west 379.50 feet to a stone found; thence north 86 degrees 43 minutes 25 seconds west 1308.68 feet to the place of beginning, containing nine and ninety-seven hundredths (9.97) acres more or less.

Beginning at a stone found at the northeast corner of the northwest quarter of Section 16; thence south 3 degrees 11 minutes 49 seconds west 1444.08 feet to an iron pin set; thence north 87 degrees 31 minutes 55 seconds west 1444.08 feet to an iron pin set; thence north 3 degrees 11 minutes 49 seconds east 1444.08 feet to a point on the north line of Section 16; thence along the north line of Section 16 south 87 degrees 31 minutes 55 seconds east 1444.08 feet to the place of beginning, containing forty-seven and eighty-seven hundredth (47.87) acres more or less.

Being all of Parcel #08-15-16-04-000 (46.87 acres) and all of Parcel #08-15-16-03-000 (1.00 Acres).

Subject to the easements of Restless Road.


