

0.94 Acre Split for Access and Utilities

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, and being part of the Northeast Quarter of the Southwest Quarter of Section 13, Township 11, Range 13, Congress Lands East of the Scioto River, and being part of the lands presently owned by Jamey A. and Amy J. Krouskoupf(OR 2025-245), being a twenty five feet wide parcel of land to be used for ingress, egress, and utilities, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at an iron pin found at the Northwest Corner of the East Half of the Southwest Quarter of Section 13;

Thence along the south line of lands presently owned by Rebecca and Dan Terrible(OR 1507-566), North 88 degrees 00 minutes 18 seconds East for a distance of 59.20 feet to an iron pin set;

- 18.) North 67 degrees 01 minutes 01 seconds West for a distance of 166.37 feet to the principal place of beginning, containing 0.94 acres more or less;

Subject to all legal right of ways and easements written or implied.

Iron pins set are 5/8" rebars 30" long, with plastic I. D. Caps.

Bearings are based on the south line of the Northeast Quarter of Section 14, as per previous survey performed by S. Walton, and being South 88 degrees 58 minutes 44 seconds West.


