PARCEL SPLIT 4 4.610 ACRES

Thence along the centerline of said State Route 555, and the westerly line of said Grantor, the following 2 courses:

- 1. (L1) North 02°32'13" West, a distance of 254.52 feet to a point;
- 2. Following a curve (C1) to the left, having a delta angel of 002.9766°, a radius 1894.29 feet, an arc length 98.41 feet, a chord bearing North 04°01'31" West, and a chord distance 98.40 feet to a point;

Thence passing through lands of the Grantor the following 2 courses:

- (L23 & L22) North 87°35'48" East, a distance of 368.39 feet to a 5/8 inch capped rebar set, being the POINT OF BEGINNING of the PARCEL herein described on the northwesterly line of the Grantor, also being the easterly line of a 23.47 acre tract of land (formerly Zanesville & Western Railway Company), now or formerly conveyed to Goss Realty Corporation, by a deed recorded in Deed Volume 707, Page 117 of the records of the Muskingum County Recorder's Office;
- 2. North 87°35′48" East, a distance of 785.39 feet to the centerline of Brush Creek, the southeasterly line of the Grantor and the northwesterly line of a 9.015 acre tract of land, now or formerly conveyed to Stephen and Kathryn Kelso, by a deed recorded in Official Record 2102, Page 0235 of the records of the Muskingum County Recorder's Office, passing a 5/8 inch capped rebar at 685.39 feet;

Thence along the centerline of Brush Creek, the southeasterly line of the Grantor and the northwesterly line of said Kelso the following 3 courses:

- 1. (L7) South 24°17′52" West, a distance of 128.51 feet to a point;
- 2. (L8) South 54°15'05" West, a distance of 140.41 feet to a point;
- (L9) South 69°15'53" West, a distance of 95.95 feet to a point, the northeasterly corner of a 2.02 acre tract of land, now or formerly conveyed to Connie and Ronnie Wilson, by a deed recorded in Deed Volume 1152, Page 0302 of the records of the Muskingum County Recorder's Office;

Thence along the centerline of Brush Creek, the southeasterly line of the Grantor, and the northwesterly line of said Wilson the following 3 courses:

- 1. (L10) North 85°56'47" West, a distance of 20.89 feet to a point;
- 2. (L11) South 79°31'32" West, a distance of 87.25 feet to a point;
