 $1^{\circ}02'00''$  East.

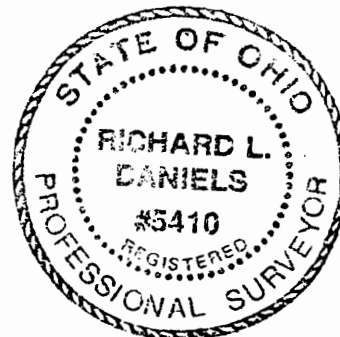
