

Survey for B. Miller

Being a part of land located in the State of Ohio, County of Muskingum, Township of Brush Creek and being part of the Northeast Quarter of Section 17, Township 11 North, Range 13 West bounded and described as follows:

Commencing at an iron pipe found disturbed at the southwest corner of the northeast quarter of Section 17, also being on the south line of a 25' roadway easement;

thence leaving the south line of said 25' roadway easement along the west line of said northeast quarter North 05 degrees 00 minutes 00 seconds East 25.00 feet to an iron pin found on the north line of said 25' roadway easement the **principle place of beginning** for this parcel;

thence continuing along the west line of said northeast quarter North 04 degrees 22 minutes 49 seconds East 385.11 feet to an iron pin found disturbed on the northeast corner of D. & L. Wiseman (DR 922-305) and on the south line of A. & S. Maxwell (DR 1113-309);

thence leaving the west line of said northeast quarter and along the south line of A. & S. Maxwell (DR 1113-309) North 89 degrees 55 minutes 33 seconds East 39.40 feet to an iron pin set at the northwest corner of S.M. & B.K. Miller (DR 1105-483);

thence leaving the south line of A. & S. Maxwell (DR 1113-309) and along the west line of S.M. & B.K. Miller (DR 1105-483) South 00 degrees 58 minutes 00 seconds East 200.65 feet to an iron pin set;

thence continuing along the west line of S.M. & B.K. Miller (DR 1105-483) South 00 degrees 58 minutes 00 seconds East 190.04 feet to an iron pin set on the southwest corner of S.M. & B.K. Miller (DR 1105-483) on the north line of a 25' wide roadway easement;

thence leaving the west line of S.M. & B.K. Miller (DR 1105-483) and along the north line of said 25' wide roadway easement North 85 degrees 00 minutes 00 seconds West 75.69 feet to the principle place of beginning, containing 0.51 acres, more or less.

Iron pins set are 5/8 inch rebar 30 inches long with identification caps (SWIERZ 8062). This legal description was prepared by Denis P. Swierz Reg. Surv. No. 8062, based on a field survey made in June 2001 by DADECO Engineering. Subject to all easements, right of ways, restrictions, reservations, etc.. of record and those that may be implied.





T11, R13






