[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, being in the Northeast Quarter of Section 17, Township 11 North, Range 13 West, Congress Lands, being within a 1.350 acre tract conveyed to **James H. Swartz and Brenda L. Swartz** by Official Record Book 2009, Page 147, Recorder's Office, Muskingum County Ohio, and also known as Auditor's Parcel No. 08-08-20-17-73-000, being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline existing right of way State Route 555 for MUS-555-6.43, made by the Ohio Department of Transportation and being located within the following described Points in the boundary thereof:

PARCEL NO. 3-T

Beginning at a point on the existing westerly right of way line of State Route 555, said point being 40.00 feet left of centerline existing right of way State Route 555 station 342+00.00 and being the **TRUE POINT OF BEGINNING** for a parcel herein described;

Thence along the existing westerly right of way line, South 87 degrees 30 minutes 30 seconds West a distance of 25.00 feet to a point, said point being 65.00 feet left of centerline existing right of way State Route 555 station 342+00.00;

Thence North 24 degrees 04 minutes 24 seconds East across the Grantor's tract, a distance of 55.90 feet to a point on the existing westerly right of way line, said point being 40.00 feet left of centerline existing right of way State Route 555 station 342+50.00;

Thence South 02 degrees 29 minutes 30 seconds East along said existing right of way line, 50.00 feet to the **TRUE POINT OF BEGINNING**.

It is understood that the parcel of land described contains, 0.014 acres, more or less, including the present road which occupies, 0.000 acres, more or less, is located in Muskingum County Auditor's Permanent Parcel No. 08-08-20-17-73-000.
