Commencing at an iron pin found at the Southeast corner of Lot 34 of Hardman Addition to Cannelville; Thence South $89^{\circ}59'00''$ West 79.80 feet to an iron pin found, the place of beginning; Thence South $27^{\circ}24'00''$ East 13.65 feet to an iron pipe found; Thence South $07^{\circ}05'24''$ East 110.60 feet to a point in the center of Township Road passing an iron pin found at 85.07 feet; Thence along center of road, the next two courses and distances – North $75^{\circ}08'00''$ West 110.86 feet to a point and North $63^{\circ}25'28''$ West 102.05 feet to a point; Thence North $18^{\circ}44'00''$ East along Julia Bowers Volume 1009, page 143, 155.95 feet to an iron pin set on the South line of Manly Street passing an iron pin found at 17.31 feet; Thence along Manly Street, North $89^{\circ}59'00''$ East 76.60 feet to an iron pin found; Thence South $27^{\circ}24'00''$ East 112.56 feet to the place of beginning containing 0.66 Acres more or less.

Bearings are based on Manly Street bearing $89^{\circ}59'00''$ East.

Iron pins set are No. 5 reinforced bars 30 inches long with plastic ID caps.

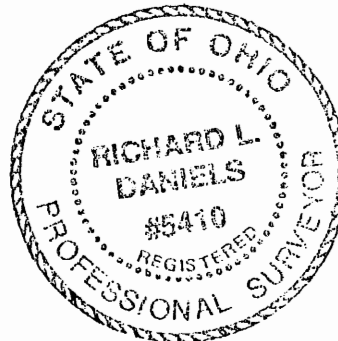

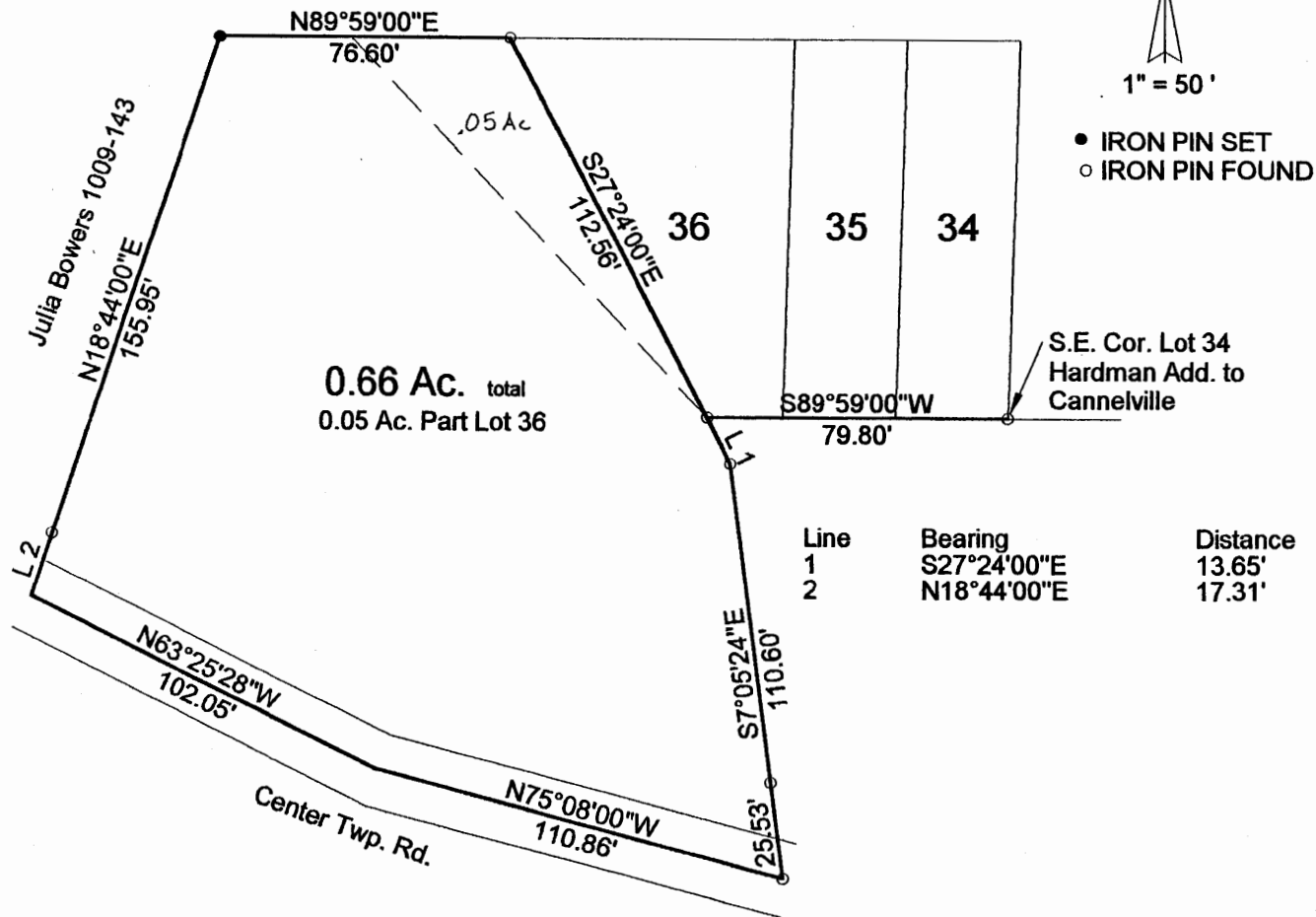
