

ALLEY VACATION

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, Township 11, Range 13, Section 27, Cannelville Plat Book 2, page 38, bounded and described as follows:

Beginning at the Northwest corner of Lot 14 of Cannelville Plat Book 2, page 38; Thence North $03^{\circ}23'06''$ East along East line of Columbus Street (35.00' feet wide) 16.22' feet to a point, passing a iron pin set at 8.11' feet; Thence North $71^{\circ}00'00''$ East along North line of alley and South lines of Lots 40, 39, 38, 37, 36 and 35, 264.01' feet to a point on West line of Barr Drive (40.00' feet wide); Thence along Barr Drive South $19^{\circ}00'00''$ East 15.00' to a point, passing a iron pin set at 7.50' feet; Thence South $71^{\circ}00'00''$ West along South line of alley and along North lines of Lots 20, 19, 18, 17, 16, 15 and 14, 270.19' feet to the place of beginning. Containing 0.0921 Acres more or less.

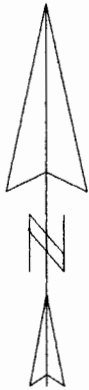
PLAT OF ALLEY VACATION

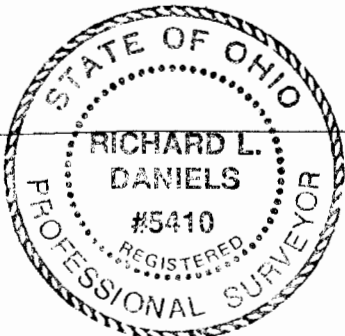
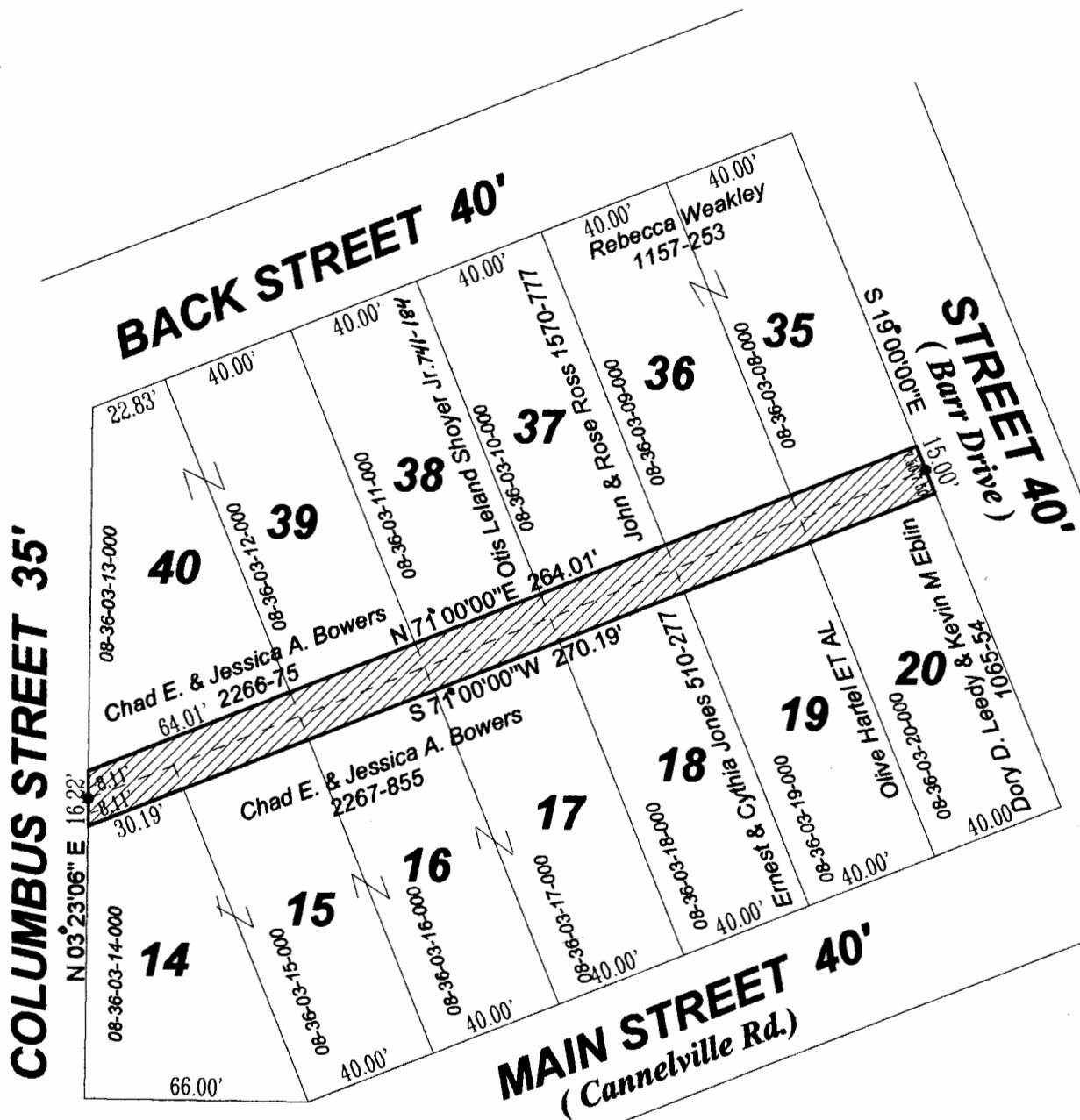
