Situate in the State of Ohio, County of Muskingum, Township of Brush Creek, and being part of the North Half of the Southeast Quarter of Section # 24, Township 11 North, Range 13 West, of the Congress Lands East of the Scioto River and being a part of Tract 1 as conveyed to Ronald Lee and Doris Lee Welch in Deed Volume 1111, Page 130, of the Muskingum County Deed Records, and being more particularly bounded and described as follows:

Beginning for reference at an iron pin found at the Southwest corner of the Southeast Quarter of Section # 24, thence along the Mid line of Section # 24, North 05 degrees 08 minutes 44 seconds East 1530.11 feet to a point on the East Right of Way line of the abandoned New York Central Railroad and The True Place of Beginning ; thence along said section line, North 05 degrees 08 minutes 44 seconds East 629.05 feet to a P.K.Nail set in the centerline of State Route # 555 (Center Road); thence along a new line in said centerline, South 05 degrees 11 minutes 25 seconds East 289.34 feet to a P.K.Nail set ; thence along said centerline and a new line South 08 degrees 16 minutes 00 seconds East 346.18 feet to a P.K.Nail set; thence along a new line, North 53 degrees 13 minutes 32 seconds East 96.35 feet to an iron pin set in Turkey run creek ; thence North 27 degrees 42 minutes 24 seconds East 54.53 feet to an iron pin set in Brush Creek ; thence South 81 degrees 43 minutes 01 seconds East 119.49 feet to an iron pin set ; thence South 57 degrees 25 minutes 43 seconds East 164.06 feet to an iron pin set ; thence South 02 degrees 31 minutes 11 seconds East 198.53 feet to an iron pin set ; thence North 84 degrees 05 minutes 09 seconds West 419.47 feet to an iron pin set on the East Right of Way line of the New York Central Railroad ; thence along said Right of Way on the arc of a curve to the left 23.58 feet to an iron pin set, said curve has a radius of 1467.50 feet and a chord which bears North 27 degrees 08 minutes 52 seconds West 23.58 feet ; thence continuing along said Right of Way North 27 degrees 36 minutes 30 seconds West 155.66 feet to the True place of beginning.
