

Tract Three

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, and being part of the Northwest Quarter of Section 22, Township 11, Range 13, Congress Lands East of the Scioto River, and being all of Parcel Four as described in DR 1148-373, and presently owned by Keith Mautz, and being more particularly described as follows:

Beginning for reference at an iron pin found at the Northeast Corner of the Northwest Quarter of Section 22, Township 11, Range 13, Congress Lands East of the Scioto River;

Thence along the east line of lands presently owned by R. and S. Seyerle(OR 1148-226), (by deed calculation) South 00 degrees 42 minutes 18 seconds West, 576.76 feet to an iron pin(by deed);

Thence along said Seyerle's south line, by deed, North 89 degrees 19 minutes 28 seconds West, 1097.30 feet to an iron pipe found on a northeast corner of lands presently owned by W. Shubert(OR 1157-270), and the principal place of beginning;

Thence along the line of said Shubert lands, South 00 degrees 40 minutes 32 seconds West, 125.00 feet to an iron pin set;

Thence along a line of said Shubert lands and the line of lands presently owned by M. Hartley(DR 563-462), North 85 degrees 34 minutes 48 seconds West, 160.00 feet to a point in Sealover Hollow Road(Twp. Rd. 140), passing an iron pin set at 132.43 feet;

Thence along said Hartley lands and lands presently owned by M. and H. Wilson(OR 1707-42), North 12 degrees 07 minutes 39 seconds East, 330.00 feet to a point in Irish Ridge Road(Co. Rd. 32) and also being a point on the west line of said Seyerle lands;

Thence along said west line the following two courses:

- 1.) South 24 degrees 19 minutes 28 seconds East, 222.75 feet to an iron pin set, passing an iron pin set at 24.00 feet;
- 2.) South 00 degrees 40 minutes 32 seconds West, 7.00 feet to the principal place of beginning, containing 0.743 acres more or less.

Subject to all recorded legal right of ways and easements.

Iron pins set are 5/8" rebars 30" long, with plastic I. D. Caps.

Bearings are based on an assumed north meridian and are for angular calculations only.
