## DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Harrison, T-11, R-13, being a part of Pletcher V 516 P 521, being part of the Northwest Quarter of Section 21, and more particularly described as follows:

( TRACT 1 ) Beginning at a stone at the Northwest Corner of Section 21; thence along the North line of Section 21 North 89 Degrees 58 Minutes 57 Seconds East 622.94 feet to an iron pin set and the place of beginning; thence continuing along said line North 89 Degrees 58 Minutes 57 Seconds East 592.70 feet to a stone; thence leaving said North line along the East line of the West Half of the Northwest Quarter of Section 21 South 00 Degrees 07 Minutes 31 Seconds East 1649.08 feet to a point in the center of Duncan Run Creek, passing a railroad spike found at 1619.03 feet in the centerline of Township Road 139; thence along the center of said creek South 65 Degrees 12 Minutes 00 Seconds West 301.18 feet to a point in said creek; thence leaving said creek North 05 Degrees 33 Minutes 41 Seconds West 697.63 feet to an iron pin set, passing iron pins set at 40.83, 377.14 and 489.87 feet and the centerline of Township Road 139 at 22.68 feet; thence North 13 Degrees 17 Minutes 21 Seconds West 1110.62 feet to the place of beginning, containing 16.06 acres, more or less, subject to all legal highways and easements.

( TRACT 2 ) Beginning at the Northwest Corner of Section 21; thence along the North line of Section 21 North 89 Degrees 58 Minutes 57 Seconds East 622.94 feet to an iron pin set; thence leaving said North line South 13 Degrees 17 Minutes 21 Seconds East 1110.62 feet to an iron pin set; thence South 05 Degrees 33 Minutes 41 Seconds East 697.63 feet to a point in the center of Duncan Run Creek, passing iron pins set at 207.76, 320.49 and 656.80 feet; thence along said creek the following 5 courses to points: South 65 Degrees 12 Minutes 00 Seconds West 20.25 feet; thence South 50 Degrees 05 Minutes 19 Seconds West 160.53 feet; thence South 66 Degrees 35 Minutes 21 Seconds West 374.85 feet; thence South 49 Degrees 00 Minutes 17 Seconds West 155.79 feet; thence South 22 Degrees 01 Minutes 51 Seconds West 109.09 feet to a point in said creek; thence leaving said creek North 67 Degrees 47 Minutes 23 Seconds West 321.66 feet to a stone on the West line of Section 21 and the East line of Brush Creek Township, passing an iron pin set at 38.97 in the centerline of Township Road 139; thence along the West line of Section 21 North 00 Degrees 06 Minutes 32 Seconds West 275.27 feet to an iron pin set; thence leaving Harrison Township 53.88 feet on a curve to the left having a radius of 1196.28 feet the chord bears South 46 Degrees 26 Minutes 25 Seconds West 53.88 feet to a point; thence North 86 Degrees 54 Minutes 31 Seconds West 432.40 feet to an iron pin found; thence North 00 Degrees 10 Minutes 51 Seconds West 1855.61 feet to an iron pin set on the North line of Section 22; thence along said North line North 89 Degrees 58 Minutes 57 Seconds East 473.17 feet to the place of beginning, leaving after the following exceptions 20.23 acres in Brush Creek Township and 34.78 acres in Harrison Township.

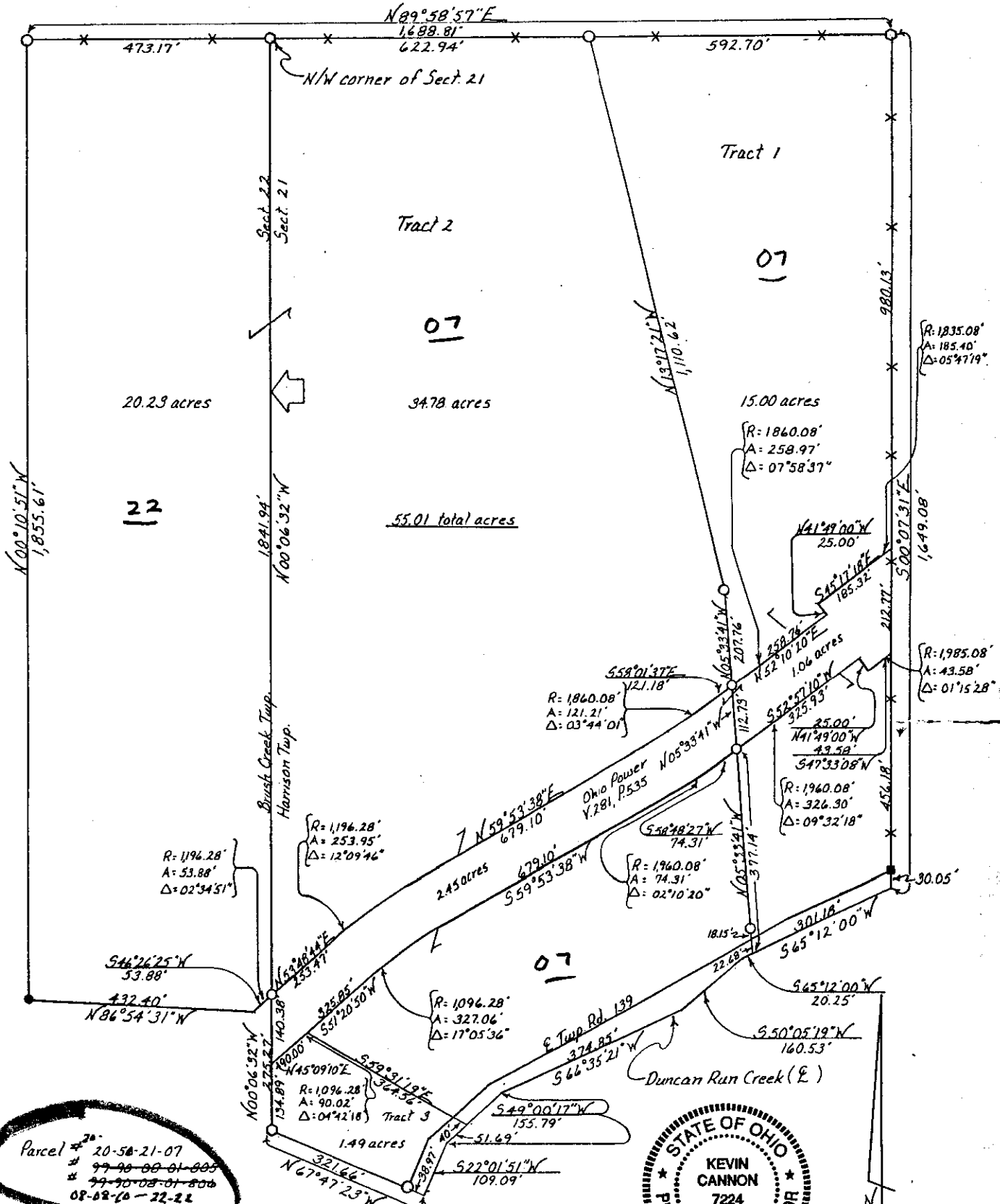
