Situated in the State of Ohio, County of Muskingum, Township of Brush Creek and being a part of the West Half of Section 7, Township 10, Range 13, part of the lands now owned by James B. Kessinger as recorded in OR 2383-895 of the Muskingum County Recorder's Office and more fully described as follows.

Beginning at an iron pin found at the northeast corner of the said southwest quarter, thence with the mid-section line, S 03°19'52" W a distance of 383.64 feet to a point in the center of Goosecreek Road (TR-134), passing an iron pin found (5/8" no cap) at 354.41 feet;

Thence with the center of said Goosecreek Road, S 38°45'53" W a distance of 151.71 feet to a point;

Thence leaving the center of said Goosecreek Road and going through said James B. Kessinger's lands the following five (5) courses:

1. N 39°21'41" W a distance of 482.35 feet to an iron pin set, passing an iron pin set at 31.51 feet;
2. N 14°59'40" W a distance of 122.19 feet to an iron pin set;
3. N 07°15'23" W a distance of 56.61 feet to an iron pin set;
4. S 86°40'08" E a distance of 229.87 feet to an iron pin set;
5. S 82°02'50" E a distance of 234.73 feet to the principal place of beginning, containing 3.613 acres, more or less, subject to all legal highways and easements of record.

Appended to the above-described parcel is an easement for the purpose of ingress/egress being described as follows:

Beginning at an iron pin set at the northwest corner of the above-described parcel, thence with the western line of said parcel the following three (3) courses;

1. S 07°15'23" E a distance of 56.61 feet to an iron pin set;
2. S 14°59'40" E a distance of 122.19 feet to an iron pin set;
3. S 39°21'41" E a distance of 482.35 feet to a point in the center of said Goosecreek Road;

Thence with the center of said Goosecreek Road, S 33°22'18" W a distance of 52.36 feet to a point;

Thence leaving the center of said Goosecreek Road and going through said Kessinger's lands the following four (4) courses:

1. N 39°21'41" W a distance of 508.69 feet to an iron pin set, passing an iron pin set at 15.94 feet;
2. N 14°59'40" W a distance of 126.60 feet to an iron pin set;
3. N 07°35'34" W a distance of 78.85 feet to an iron pin set;
4. S 86°40'08" E a distance of 50.00 feet to the place of beginning, containing a total of 0.788 acres, more or less.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

The above described 3.613 acre parcel is based on a field survey made by Brian K. McPeck, PS 8517 of McPeck Land Surveying, LLC on November 17, 2021.

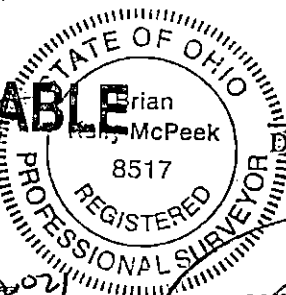
