Description of Parcel 6

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, being in Section 7, Range 13 West, Township 13 North of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for reference at an iron pin set at the southeast corner of the southwest quarter of Section 7 (Note: said iron pin being 11.00 feet west of the centerline of a 30" diameter oak tree);

thence, with the Section line, North 86°17'34" West a distance of 1,322.84 feet to an iron pin set at the southwest corner of the east half of the southwest quarter of Section 7;

thence, with the quarter-quarter section line, North 03°40'29" East a distance of 2,047.87 feet to a point, being THE TRUE POINT OF BEGINNING for this description, passing through two iron pins set at distances of plus 437.69 feet and plus 487.69 feet, respectively, and passing over the centerline of Township Road No. 134 at a distance of plus 462.69 feet;

thence, from said Point of Beginning continuing with the quarter-quarter section line, North 03°40'29" East a distance of 522.85 feet to a point;

thence, leaving the quarter-quarter section line, South 57°34'17" East a distance of 1,289.75 feet to a point in the centerline of Township Road No. 134, passing through three iron pins set at distances of plus 930.13 feet, plus 1,092.58 feet, and plus 1,276.25 feet, respectively;

thence, with the centerline of said Township Road No. 134, the following two courses:


- (1) South 24°19'42" West a distance of 123.86 feet to a point;
- (2) thence South 27°23'08" West a distance of 79.10 feet to a point at the northeast corner of a 2.049 acres Exception as described in Deed Volume _____, Page _____ of the Muskingum County Recorder's Office.

thence, leaving the road and running with the north and west lines of said 2.049 acres tract, the following two courses:

- (1) North 58°51'19" West a distance of 373.41 feet to an iron pin found, passing through an iron pin found at a distance of plus 14.60 feet;
- (2) thence South 27°57'52" West a distance of 213.09 feet to an iron pin set in an existing fence line;

All iron pins set are 1/2" rebar with yellow caps labeled "Claus 6456".


