Being a part of the Northeast Quarter of Section 7, Township 10 North, Range 13 West of the Congress Lands East of the Scioto River and being more particularly described as follows:

Commencing at an iron pin found at the southwest corner of the northeast quarter of Section 7; thence South 86 degrees 17 minutes 21 seconds East (the basis of bearings for this description being true north by the sun hour angle method) along the South line of said northeast quarter a distance of 1536.48 feet to an iron pin set; thence North 03 degrees 22 minutes 50 seconds East a distance of 1133.88 feet to an iron pin set and the point of beginning of the land to be described;

thence North 86 degrees 52 minutes 53 seconds West a distance of 264.00 feet to an iron pin set; thence North 50 degrees 02 minutes 17 seconds East along township road 134 (Goosecreek Road) a distance of 363.00 feet to an iron pin set; thence South 03 degrees 22 minutes 50 seconds West a distance of 247.94 feet to the point of beginning containing 0.751 acres more or less.
