

Description of Parcel 3

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, being in Section 7, Range 13 West, Township 10 North, of "The Congress Lands East of Scioto River", and being bounded and described as follows:

Commencing for reference at an iron pin set at the center of Section 7;

thence, with the quarter section line, South 03°39'41" West a distance of 379.31 feet to a point in the centerline of Township Road No. 134 (Goosecreek Road), passing through an iron pin set at a distance of plus 354.31 feet, said point in the centerline of road being THE TRUE POINT OF BEGINNING for this description;

thence, from said Point of Beginning continuing with the quarter section line, South 03°39'41" West a distance of 1,554.07 feet to an iron pin set, passing through an iron pin set at a distance of plus 25.00 feet;

thence, leaving the quarter-quarter section line, North 63°04'22" West a distance of 96.70 feet to an iron pin set;

thence, North 21°44'25" West a distance of 688.04 feet to a point in the centerline of said Township Road No. 134, passing through an iron pin set at a distance of plus 663.04 feet;

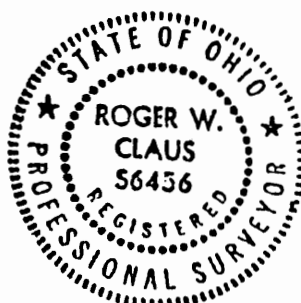
thence, with the centerline of Township Road No. 134, the following ten courses:

- (1) North 05°32'37" East a distance of 98.08 feet to a point;
- (2) thence North 21°53'07" East a distance of 45.85 feet to a point;
- (3) thence North 23°52'04" East a distance of 31.93 feet to a point;
- (4) thence North 31°15'57" East a distance of 190.29 feet to a point;
- (5) thence North 27°23'08" East a distance of 79.10 feet to a point;
- (6) thence North 24°19'42" East a distance of 123.86 feet to a point;
- (7) thence North 23°08'57" East a distance of 133.73 feet to a point;
- (8) thence North 28°05'22" East a distance of 78.19 feet to a point;
- (9) thence North 36°25'13" East a distance of 98.83 feet to a point;
- (10) thence North 39°16'27" East a distance of 105.18 feet to the Point of Beginning;

containing 8.017 acres, more or less.
