DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, T-10, R-13, being a part of Rural Estates Inc. V 1034, P 495, parcel # 08-08-70-04-25 & 26 being part of the East Half of Section 4, and more particularly described as follows:

(TRACT 5) Beginning at a Stone at the Southeast Corner of the Northeast Quarter of Section 4; thence along the East line of Section 4 North 01 Degrees 06 Minutes 09 Seconds West 1358.97 feet to an iron pin set; thence North 89 Degrees 58 Minutes 51 Seconds West 916.16 feet to an iron pin set and the place of beginning, passing an iron pin set at 453.58 feet; thence South 01 Degrees 06 Minutes 09 Seconds East 1812.19 feet to a point in the centerline of Township Road 138, passing an iron pin set at 1792.19 feet; thence with said centerline North 62 Degrees 05 Minutes 09 Seconds West 30.91 feet to a point in said centerline; thence North 56 Degrees 14 Minutes 32 Seconds West 467.80 feet to a point in said centerline; thence leaving said centerline North 00 Degrees 00 Minutes 00 Seconds East 1537.47 feet to an iron pin set, passing an iron pin set at 20.00 feet and a stone at 193.34 feet; thence South 89 Degrees 58 Minutes 51 Seconds East 381.31 feet to the place of beginning, containing 15.29 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the East line of Section 4 as being South 01 Degrees 06 Minutes 09 Seconds East.


