

Description of 39.903 Acres

The following description is a resurvey of the Bernie R. and Bob J. Anderson property as conveyed by Volume 1941, Page 481 of the Muskingum County Recorder's Office and being bounded and described as follows:

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, being in the southwest quarter of Section 5, Range 13 West, Township 10 North, of "The Congress Lands East of the Scioto River", and being bounded and described as follows:

Commencing for reference at a point at the southwest corner of Section 5 (Note: Reference bearing on the south line of the southwest quarter of the southwest quarter of Section 5 used as North 89°54'58" East.);

thence, with the south line of Section 5, North 89°54'58" East a distance of 659.93 feet to an iron pin set at the southeast corner of a 129.52 acres tract as conveyed to Holmes Woodland, Inc. by Volume 1111, Page 38 of the Muskingum County Recorder's Office, being THE TRUE POINT OF BEGINNING for this description, said iron pin set bears North 38°43'37" West a distance of 3.91 feet from an unmarked stone found;

thence, from said Point of Beginning leaving the section line and with the east line of said Holmes Woodland, Inc. property, North 38°43'37" West a distance of 947.94 feet to a point at the southwest corner of a 4.90 acres tract as conveyed to Delbert F. and Kathryn J. Ross by Volume 2143, Page 578 of the Muskingum County Recorder's Office;

thence, leaving said Holmes Woodland, Inc. property and with said Ross property, the following four courses:

1. North 54°35'14" East a distance of 334.75 feet to a 5/8" iron pin found capped "RLS 5410", passing through a 5/8" iron pin found capped "RLS 5410" at a distance of plus 0.23 feet;
2. thence North 24°26'49" West a distance of 78.00 feet to a 5/8" iron pin found capped "RLS 5410";
3. thence North 12°41'20" East a distance of 118.00 feet to a 1 1/4" pipe found;
4. thence North 29°27'41" West a distance of 275.62 feet to a point in the centerline of Township Road No. 134 (Goose Creek Road 40' R/W), passing through a square bolt found at a distance of plus 259.21 feet;

thence, leaving said Ross property and with the centerline of Township Road No. 134, the following twelve courses:

11. thence North 37°12'43" East a distance of 65.94 feet to a point;
12. thence North 58°40'02" East a distance of 54.74 feet to a point at the southwest corner of a 2.510 acres tract as conveyed to Steve Wilson by Volume 1022, Page 154 of the Muskingum County Recorder's Office;

thence, leaving the road and with the south line of said Wilson property, South 75°29'31" East a distance of 77.97 feet to a point in a run and being in the west line of a 43.4 acres tract as conveyed of Loren F. and Anillee O. Ross by Volume 1511, Page 880 of the Muskingum County Recorder's Office, passing through two 5/8" iron pins found capped "Cannon 5489" at distances of plus 25.00 feet and plus 55.00 feet, respectively;

thence, with said Ross property, the following three courses:

1. South 67°29'08" East a distance of 75.88 feet to a 5/8" iron pin set;
2. thence South 75°47'12" East a distance of 566.00 feet to a 5/8" iron pin set;
3. thence South 00°20'12" East a distance of 1,632.73 feet to a 5/8" iron pin set in the south line of Section 5;

thence, leaving said Ross property and with the south line of Section 5, South 89°54'58" West a distance of 690.63 feet to the Point of Beginning;

containing 39.903 acres, more or less, being all of Parcel No. 08700525000.

Subject to the right-of-way of Township Road No. 134 (Goose Creek Road).




SURVEY PLAT FOR COUNTRYTME


