Beginning at an iron pin found at the Northwest Corner of the Southeast Quarter of Section 8; thence South 03 Degrees 15 Minutes 19 Seconds West 1034.80 feet to an iron pin set and the place of beginning; thence South 72 Degrees 00 Minutes 28 Seconds East 296.16 feet to an iron pin set; thence South 03 Degrees 15 Minutes 19 Seconds West 299.74 feet to a point in the centerline of Twp. Rd. 253, passing an iron pin set at 275.90 feet; thence along said centerline the next 2 courses to points: North 75 Degrees 49 Minutes 24 Seconds West 129.34 feet; thence North 69 Degrees 03 Minutes 33 Seconds West 167.33 feet; thence North 03 Degrees 15 Minutes 19 Seconds East 299.74 feet to the place of beginning, passing an iron pin found at 18.00 feet, containing 2.00 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar 30 inches long, with plastic ID caps.

Bearings are based on the Mid Section Line of Section 8 as being South 03 Degrees 15 Minutes 19 Seconds West.



