**COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 5;**

**THENCE NORTH 07 DEGREES 35 MINUTES 01 SECONDS EAST 1316.12 FEET (BY DEED) TO A POINT IN THE CENTER OF TOWNSHIP ROAD 134 (GOOSE RUN ROAD), SAID POINT BEING THE SOUTHWEST CORNER OF A 1.4902 ACRE TRACT NOW OR PREVIOUSLY OWNED BY JAMES A. Mc CONNELL BY DEED RECORDED IN VOLUME 699, PAGE 116 OF THE MUSKINGUM COUNTY DEED RECORDS;**

**THENCE WITH THE WEST LINE OF THE SAID 1.4902 ACRE TRACT, NORTH 06 DEGREES 42 MINUTES 40 SECONDS EAST 673.58 FEET (BY DEED) TO A POINT, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 25.00 FEET;**

**THENCE WITH THE NORTH LINE OF THE SAID 1.4902 ACRE TRACT AND THE NORTH LINE OF A 1.1795 ACRE TRACT (NOW OR PREVIOUSLY OWNED BY D. COCHERL (BY DEED RECORDED IN VOLUME 1014, PAGE 307 OF THE SAID COUNTY RECORDS), SOUTH 68 DEGREES 09 MINUTES 50 SECONDS EAST 491.86 FEET TO AN IRON PIN SET, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;**

**THENCE TRAVERSING THROUGH A TRACT CONVEYED TO J. AND R. WILSON AS RECORDED IN VOLUME 1022, PAGE 148 OF THE MUSKINGUM COUNTY DEED RECORDS, THE NEXT TWO COURSES AND DISTANCES:**

- 1) NORTH 57 DEGREES 30 MINUTES 56 SECONDS EAST 286.58 FEET TO AN IRON PIN SET;
- 2) SOUTH 50 DEGREES 03 MINUTES 41 SECONDS EAST 126.64 FEET TO A POINT IN THE ABOVE SAID TOWNSHIP ROAD 134 (GOOSE RUN ROAD), PASSING AN IRON PIN SET AT 112.04 FEET;

**THENCE WITH THE SAID ROAD AND THE WESTERLY LINE OF A 2.51 ACRE TRACT THE NEXT THREE COURSES AND DISTANCES:**

- 1) SOUTH 37 DEGREES 41 MINUTES 37 SECONDS WEST 86.77 FEET TO A POINT;
- 2) SOUTH 55 DEGREES 46 MINUTES 50 SECONDS WEST 98.75 FEET TO A POINT;
- 3) SOUTH 68 DEGREES 41 MINUTES 40 SECONDS WEST 41.02 FEET TO A POINT;
