Beginning at a stone found at the Northwest corner of the Southwest Quarter of Section 9; Thence **South 3°35'26"West** along Ronald & Carola Miracle Volume 986, page 97, **95.88'** feet to a point in center of Brush Hill Rd., passing a iron pin found at 62.79' feet; Thence along center of Brush Hill Rd. the next three courses and distances: **South 53°33'30"East 201.33'** feet to a point, **South 45°52'50"East 140.49'** feet to a point and **South 49°07'32"East 72.70'** feet to a point; Thence leaving Brush Hill Rd. and along Jerry & Anita Graf Volume 2230, page 697, **North 46°29'30"East 150.00'** feet to a iron pin found, passing a iron pin found at 24.45' feet; Thence through Jeremy A. Moore Volume 2149, page 548 the next two courses and distances: **North 35°57'08"East 52.47'** feet to a iron pin set and **North 58°01'21"West 393.96'** feet to a iron pin set; Thence **North 86°56'05"West** along Joseph Miller Volume 1037, page 541, **117.37'** feet to the place of beginning. Containing **1.69 Acres** more or less.

Bearings are based on the North line of the West half of the Southwest Quarter, bearing South 86°56'05"East.



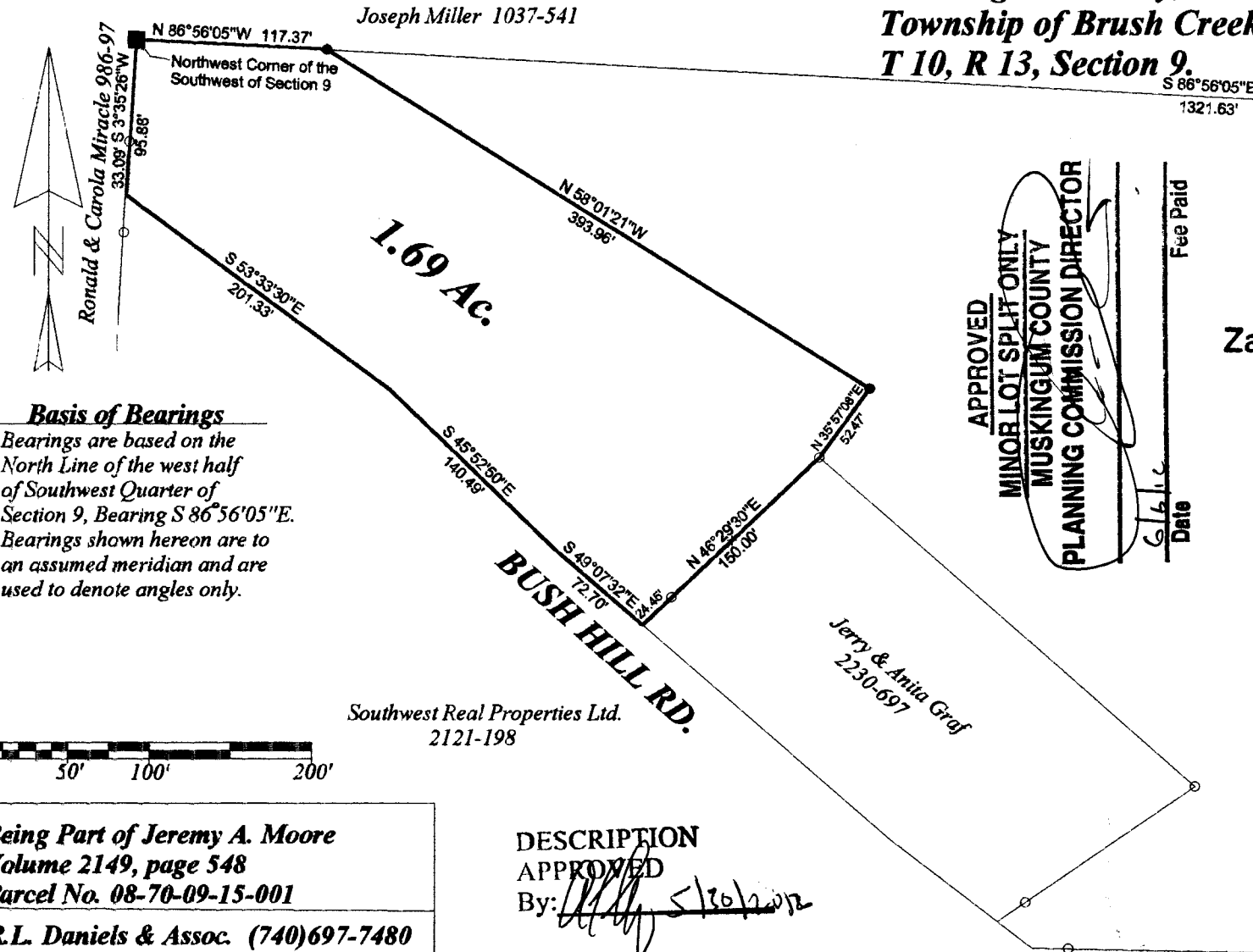

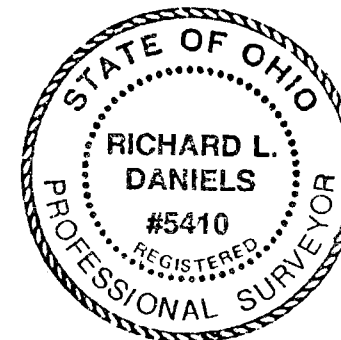
