

Re-Survey of Patricia S. Kinnaird, Trustee Lands in Brush Creek Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Brush Creek, and being part of the North Half of Section 3, Township 10, Range 13, and being part of the South Half of Section 29, Township 11, Range 13, United States Military Lands, and being all the lands presently owned by Patricia S. Kinnaird, Trustee, as per Official Record 2656, Page 398, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at a stone found at the southwest corner of the Northwest Quarter of Section 3, Township 10, Range 13, United States Military Lands;

Thence along the section line and the east line of lands presently owned by Jason Edward and Holli Ann Winters, (OR 2888-69), North 02 degrees 28 minutes 45 seconds East, 1349.38 feet to an iron pin found, on the southwest corner of lands presently owned by Gail E. Swingle, Trustee, (OR 2814-207), from which an iron pin found bears North 06 degrees 43 minutes 27 seconds East, 8.30 feet;

Thence along the lines of said Swingle lands, the following six courses:

- 1.) South 87 degrees 13 minutes 48 seconds East, 1297.72 feet to an iron pin found, from which an iron pin found bears South 12 degrees 44 minutes 54 seconds East, 8.29 feet;
- 2.) North 02 degrees 54 minutes 22 seconds East, 1344.36 feet to an iron pin found, on the section line, from which an iron pin found bears South 46 degrees 24 minutes 04 seconds West, 12.85 feet to an iron pin found;
- 3.) Along the section line, South 86 degrees 59 minutes 28 seconds East, 960.90 feet to an iron pin found;
- 4.) North 10 degrees 33 minutes 09 seconds East, 126.50 feet to an iron pin set;
- 5.) North 12 degrees 54 minutes 24 seconds East, 319.08 feet to an iron pin found;
- 6.) North 52 degrees 01 minutes 20 seconds East, 398.66 feet to a point in the centerline of Virginia Ridge Road, (Co. Rd. 66, R\W 40'), passing an iron pin found on the mid-section line at 369.38 feet;

Thence along the centerline of said road, South 75 degrees 45 minutes 48 seconds East, 16.50 feet to a point;

Thence leaving said road and along the east line of a driveway, and the lines of said Gail Swingle lands, the following three courses:

- 1.) South 31 degrees 48 minutes 54 seconds West, 80.09 feet to an iron pin set on the mid-section line, passing an iron pin set at 23.06 feet;
- 2.) Along the mid -section line, South 03 degrees 19 minutes 39 seconds West, 627.82 feet to a iron pin found, from which an iron pin bears South 38 degrees 18 minutes 21 seconds West, 26.39 feet;
- 3.) Along the section line, South 86 degrees 59 minutes 28 seconds East, 662.37 feet to an iron pin set on the northwest corner of lands presently owned by Marguerite S. Milstead, (OR 3097-61);

Thence along the lines of said Milstead lands, the following two courses:

- 1.) South 02 degrees 46 minutes 47 seconds West, 693.00 feet to an iron pin set;
- 2.) South 86 degrees 59 minutes 28 seconds East, 627.00 feet to an iron pin set on the west line
