- 3.) North 49 degrees 26 minutes 22 seconds West, 99.99 feet to an iron pin found, on the south line of lands presently owned by Kendricks Property Management LLC, (OR 2683-723);

Thence along the lines of said Kendrick lands, the following three courses:

- 1.) North 36 degrees 04 minutes 55 seconds East, 116.32 feet to an iron pin found;
- 2.) North 32 degrees 47 minutes 16 seconds East, 80.80 feet to an iron pin found;
- 3.) North 39 degrees 20 minutes 40 seconds West, 403.53 feet to an iron pipe found on the south right of way line of St. Rte. 16;

Thence along said right of way line the following three courses:

- 1.) North 56 degrees 33 minutes 39 seconds East, 273.14 feet to an iron pin found;
- 2.) North 58 degrees 04 minutes 12 seconds East, 515.07 feet to a PK Nail found;
- 3.) North 37 degrees 39 minutes 56 seconds East, 134.85 feet to an iron pipe found on the northwest corner of said Ohio Power Lands, (DR 1085-586);

Thence along the lines of said Ohio Power lands the following two course:

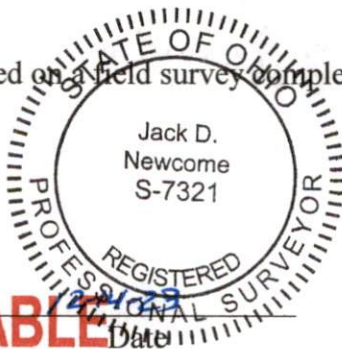

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per G.P.S. observations.
