- 2. thence, N.79°19'00"W. 231.80' to a 5/8" steel pin found;

thence, along the north & south quarter line, N.01°11'24"E. 560.83' to the TRUE POINT OF BEGINNING, containing 7.000 acres, more or less, and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.
