- 3.) Along a non-tangent curve to the right, with a delta angle of 63 degrees 12 minutes 38 seconds, an arc length of 133.54 feet, a radius of 124.56 feet, and a chord which bears North 51 degrees 54 minutes 56 seconds West, 130.55 feet to a point;
- 4.) North 21 degrees 49 minutes 27 seconds West, 146.45 feet to a point on the south line of the right of way of Raider's Road, (Co. Rd. 616);

Thence along the south right of way of said road, the following five courses:

- 1.) North 59 degrees 17 minutes 50 seconds East, 41.27 feet to an iron pin found;
- 2.) South 30 degrees 15 minutes 57 seconds East, 20.00 feet to a right of way monument found, (disturbed);
- 3.) Along a curve to the right, with a delta angle of 13 degrees 00 minutes 18 seconds, and arc length of 629.81 feet, a radius of 2774.93 feet, and a chord which bears North 66 degrees 16 minutes 32 seconds East, 628.50 feet to a right of way monument found;
- 4.) North 17 degrees 16 minutes 32 seconds West, 50.00 feet to an iron pin found;
- 5.) Along a curve to the right, with a delta angle of 2 degrees 32 minutes 36 seconds, an arc length of 125.39 feet, a radius of 2824.93 feet, and a chord which bears North 74 degrees 00 minutes 19 seconds East, 125.38 feet to an iron pin set;

Thence leaving said right of way and through the lands presently owned by Robert B. and Bobbi J. Vernon, (OR 2614-950) the following six courses;

- 1.) South 17 degrees 14 minutes 45 seconds East, 66.99 feet to an iron pin set;
- 2.) South 58 degrees 13 minutes 03 seconds West, 168.21 feet to an iron pin set;
- 3.) South 58 degrees 14 minutes 44 seconds West, 168.27 feet to an iron pin set;
- 4.) South 67 degrees 18 minutes 04 seconds West, 166.85 feet to an iron pin set;
- 5.) South 11 degrees 41 minutes 00 seconds East, 312.36 feet to an iron pin set;
- 6.) South 05 degrees 41 minutes 04 seconds East, 33.86 feet to the principal place of beginning, containing 2.92 acres, more or less, and being part of Auditor's Parcel Number 10-04-04-25-000.
