

5 Acre Split for R. & B. Carpenter

Situated in the State of Ohio, County of Muskingum, Township of Cass, bounded and described as follows:

Being a part of the East Half of the Northeast Quarter of Section 5, Township 3 North, Range 8 West, United States Military Lands, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at an iron pin set, on the Northwest Corner of the East Half of the Northeast Quarter of Section 5, thence along the Muskingum\Coshocton County line and the north line of lands presently owned by C. R. And B. A. Carpenter, South 85 degrees 03 minutes 20 seconds East 425.40 feet to an iron pin set, passing the centerline of Welker Road(Twp. Rd. 400) at 55.26 feet; thence leaving said county line and through said Carpenter land's South 04 degrees 33 minutes 49 seconds West, 499.77 feet to an iron pin set at the edge of the woods on a power line clearing; thence along said clearing North 88 degrees 11 minutes 09 seconds West 382.37 feet to an iron pin set at an angle point on said clearing; thence along said clearing, South 76 degrees 58 minutes 22 seconds West, 45.60 feet to an iron pin set on the East line of lands presently owned by A. Meadows(DR 685-316); thence along said Meadow land's and the east line of lands presently owned by E. Hindel(DR 1093-614), North 04 degrees 33 minutes 50 seconds East, 534.72 feet to the principal place of beginning, passing the centerline of Welker Road(Twp. Rd. 400) at 452.94 feet, containing 5.00 acres more or less, subject to all legal right of ways and applicable easements, written or implied.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.

Bearings are based on the NAD 83, Ohio State Plane Coordinate System, Grid North, as per GPS observations.




BASIS OF BEARING
