

Tract Nine 1.33 Acre Split for R. & B. Carpenter

Situated in the State of Ohio, County of Muskingum, Township of Cass, bounded and described as follows:

Being a part of the East Half of the Northeast Quarter of Section 5, Township 3 North, Range 8 West, United States Military Lands, and being a part of lands presently owned by C. Rodney and Betty Ann Carpenter(DR 814-25) and more particularly described as follows:

Beginning for reference at an iron pin found, at the Southeast Corner of the Northeast Quarter of Section 5, thence along the section line, North 04 degrees 31 minutes 03 seconds East, 70.14 feet to an iron pin found; thence continuing along said section line North 04 degrees 31 minutes 03 seconds East, 40.00 feet to the center of School House Road(Twp. Rd. 118) and the principal place of beginning; thence along said centerline the following four courses: 1.) North 22 degrees 36 minutes 26 seconds West, 24.04 feet to a point; 2.) North 20 degrees 25 minutes 32 seconds West, 172.60 feet to a point; 3.) North 25 degrees 25 minutes 38 seconds West, 138.11 feet to a point; 4.) North 22 degrees 43 minutes 10 seconds West, 204.69 feet to a point; thence leaving said road and through said Carpenter lands, South 85 degrees 18 minutes 20 seconds East, 246.37 feet to an iron pin set on the east line of section five, passing an iron pin set at 25.00 feet; thence along said section line, South 04 degrees 31 minutes 03 seconds West, 478.81 feet the principle place of beginning, passing an iron pin found at 428.57 feet; containing 1.33 acres more or less, subject to all legal right of ways and applicable easements, written or implied.

The above described parcel is subject to a 7.5 feet wide utility easement which parallels the north line of the above described tract.

Iron pins set are 5/8 inch diameter by 30 inch long rebar with plastic identification caps.

Bearings are based on NAD 83, Ohio State Plane Coordinate System, South Zone, Grid North, as per GPS observations from previous surveys performed by Jack D. Newcome.

This description is written based on a field survey completed on Feb. 21, 2004 by Jack D. Newcome, Reg. No. 7321.




