Situated in the Southeast Quarter of Section #7, T-3-N, R-8-W, Cass Township, Muskingum County, Ohio. Being part of the lands of Stephen & Ruth Bowman as recorded in the Muskingum County deed records and being described as follows:

Commencing at a stone found marking the Northeast corner of the Southeast quarter of section #7; thence, S.00°11'55"E. a distance of 1,260.38 feet along the East line of said quarter section to a point, located near the center of Township Road #118 (Schoolhouse Road), Being the point of beginning;

thence, S.00°11'55"E. a distance of 160.00 feet along the east line of said quarter section to a point;

thence, S.89°48'05"W. a distance of 275.00 feet through the lands of S. & R. Bowman to a set rebar, passing a set rebar at 30.00 feet;

thence, N.00°11'55"W. a distance of 160.00 feet through said Bowman lands to a set rebar;

thence, N.89°48'05"E. a distance of 275.00 feet through said Bowman lands to the point of beginning, passing a set rebar at 245.00 feet.

The above described parcel contains 1.010 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars. North is based upon an assumed meridian.




