Being a part of the First Quarter of Township ³N., Range 7W., and being more particularly described as follows:

Commencing at an iron pipe at the Northwest corner of said First Quarter, said iron pipe being on the County line between Muskingum and Coshocton Counties;

thence, with the North line of said First Quarter and said County line, S.86°45'00"E. a distance of 333.78 feet to an iron pipe found;

thence, with the property lines of Ellen Gray Marsh, et.al., the following two courses:

1. thence, S.2°19'41"E. a distance of 3.94 feet to an iron pipe found;
2. thence, S.61°30'25"E. a distance of 385.64 feet to an iron pipe set, said iron pipe set being the True Place of Beginning of the land herein described;

thence, continuing S.61°30'25"E. a distance of 93.70 feet to a stone found;

thence, with the Presbyterian Church property lines the following two courses:

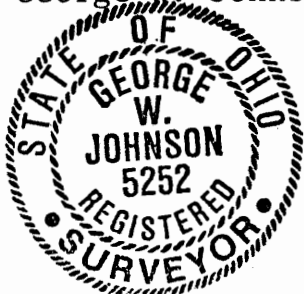
1. thence, S.23°07'00"E. a distance of 118.80 feet to an iron pipe found;

2. thence, N.59°34'21"W. a distance of 153.00 feet to an iron pipe set;
3. thence, N.27°05'38"E. a distance of 68.20 feet to an iron pipe set;
4. thence, N.27°34'22"W. a distance of 138.70 feet to an iron pipe set;
5. thence, N.28°30'10"E. a distance of 246.37 feet to the True Place of Beginning, containing 2.419 acres, more or less, including all public road right of way and subject to all easements of record.

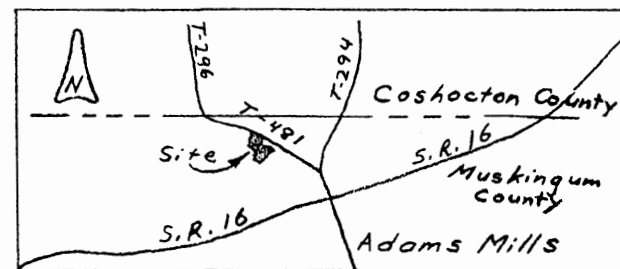
