Situated in the State of Ohio, County of Muskingum, Township of Cass, Lot 24, Quarter Township 4, Township 3, Range 8 and being part of the lands now owned by Jon M. & Donna McMahon as recorded in DR 531-319 of the Muskingum County Recorders Office more particularly described as follows.

Beginning for reference a iron pin found at the northwest corner of Lot 24 and going with the common line of Lot 24 and Lot 21, South 00 degrees 59 minutes 12 seconds West, 1093.66 feet to a point in the center of Lockman Lane (T-153), also being a southwesterly corner of the lands now owned by Charles L. Jr., & Brenda Ford (DR 1142-750);

thence the roadbed of said Lockman Lane the following two (2) courses:

- 1. South 24 degrees 21 minutes 48 seconds East, 84.25 feet to a point;
- 2. South 66 degrees 21 minutes 48 seconds East, 614.52 feet to a point, and the principal place of beginning;

thence continuing with said roadbed the following two (2) courses:

- 1. South 66 degrees 21 minutes 48 seconds East, 198.58 feet to a point;
- 2. North 88 degrees 08 minutes 12 seconds East, 90.49 feet to a point, said point being on the south line of the lands now owned by Bradley S. & Mary A. Kaufmann (DR 1140-77):

thence leaving said roadbed and going through said McMahon's lands the following three (3) courses:

- 1. South 46 degrees 23 minutes 26 seconds West, 277.10 feet to an iron pin set, passing an iron pin set at 8.26 feet;
- 2. North 72 degrees 39 minutes 07 seconds West, 145.94 feet to an iron pin set;
- 3. North 16 degrees 45 minutes 50 seconds East, 234.24 feet to the point of beginning, passing an iron pin set at 223.85 feet, containing a total of 1.078 acres more or less, subject to all legal highways and easements of record.

Appended to: The above described tract has an easement for the purpose of maintaining an existing sanitary leach area appended to it, said easement is more particularly described as follows:

Beginning at the southwest corner of the above described 1.078 acre tract, thence going through Tract 1 (3.744 Acres), North 72 degrees 39 minutes 07 seconds West, 60.00 feet to a point;

thence North 16 degrees 45 minutes 50 seconds East, 50.02 feet to a point;

thence South 72 degrees 39 minutes 15 seconds East, 60.00 feet to a point;

thence South 16 degrees 45 minutes 50 seconds West, 50.03 feet to the point of beginning, containing a total of 0.068 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

The above described 1.078 acre parcel and 0.068 acre easement is based on a field survey made by McPeek Land Surveying on September of 2014.
