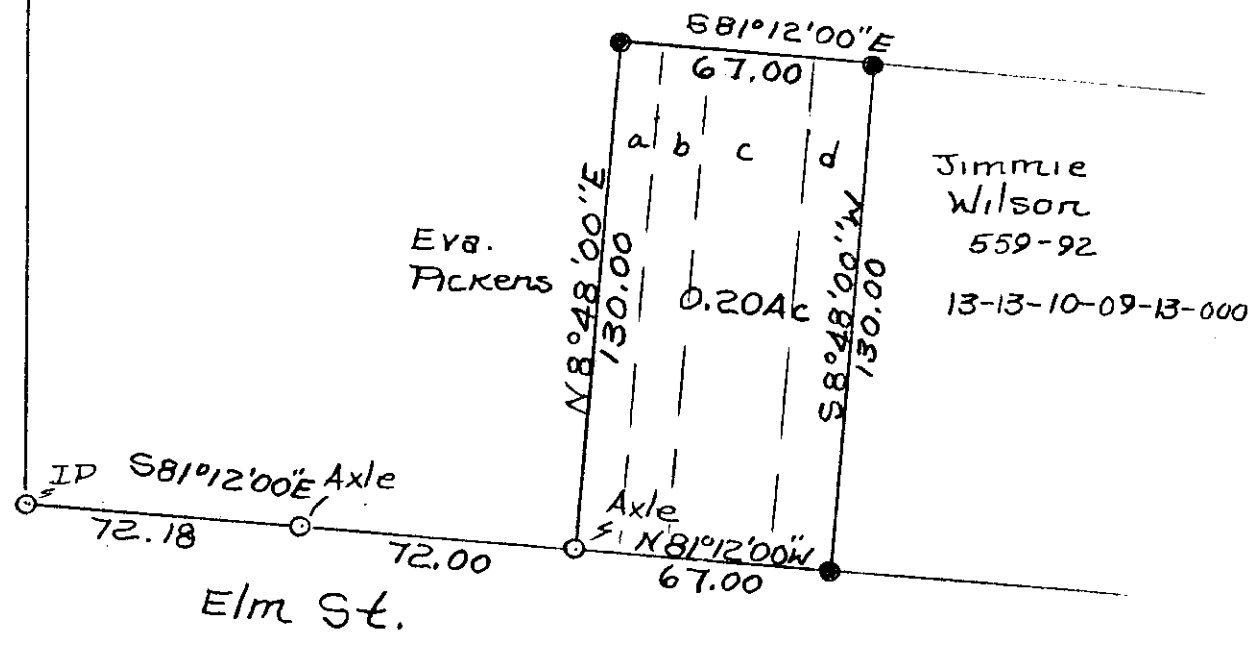

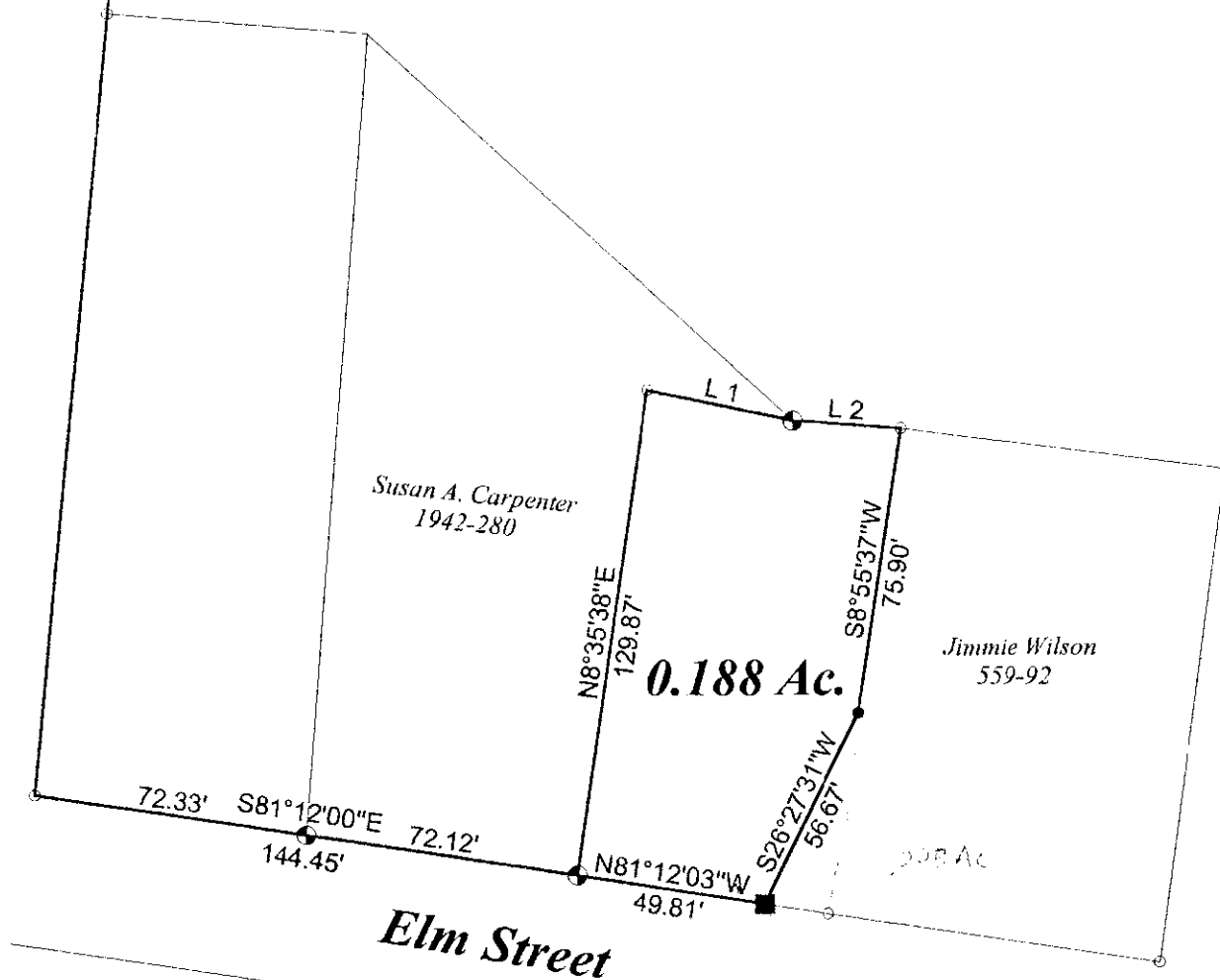
Northwest Corner
