Iron pins set are No. 5 reinforced bars 30" inches long with plastic I.D. caps.

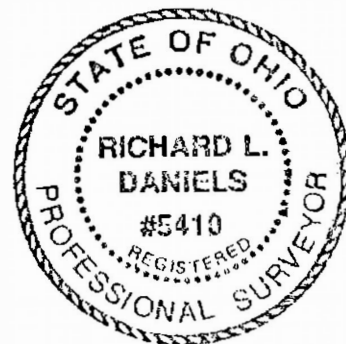

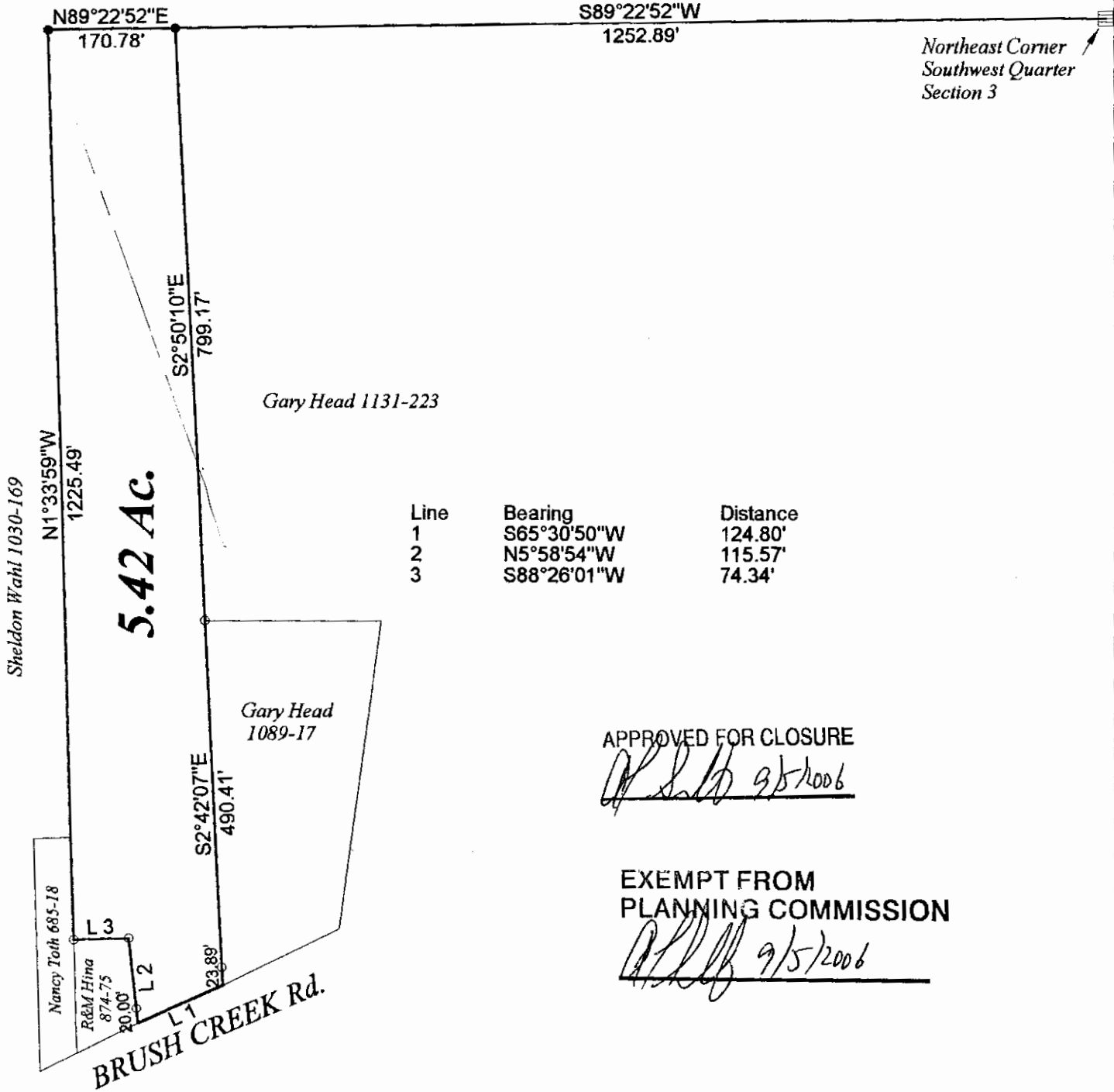
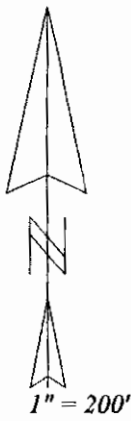
