## Survey for Glenn R. Parker

(Village of Roseville Pump Station #5)

Being a part of land located in the State of Ohio, County of Muskingum, part of Lot 14 of the Lenhart and Brown's Addition to the Town of Roseville (Re-Plat 1, Page 90), Township 14 North, Range 14 West. Being part of the lands conveyed to Glenn R. Parker in Deed Record 2127, page 403, bounded and described as follows:

Commencing at the northwest corner of Lot 15 of the Lenhart and Brown's Addition to the Town of Roseville (Re-Plat Book 1, page 90);

thence along the east line of Main Street (60' wide) and along the west line of Lot 15 South 03 degrees 38 minutes 47 seconds West 50.89 feet to a point on the north line of Bridge Alley (12' wide);

thence along the north line of Bridge Alley South 86 degrees 21 minutes 13 seconds East 84.41 feet to an iron pin found disturbed;

thence continuing along the north line of Bridge Alley South 86 degrees 21 minutes 13 seconds East 20.20 feet to an iron pin found;

thence continuing along the north line of Bridge Alley South 86 degrees 21 minutes 13 seconds East 60.39 feet to a point, being the southeast corner of Lot 15 and on the west line of Potter Alley (12' wide);

thence along the west line of Potter Alley (12' wide) and across Bridge Alley (12' wide) South 03 degrees 38 minutes 47 seconds West 12.00 feet to a point on the south line of Bridge Alley (12' wide), being the northeast corner of Lot 14;

thence along the east line of Lot 14 and the west line of Potter Alley (12' wide) South 03 degrees 38 minutes 47 seconds West 12.00 feet to a railroad spike set, the **place** of beginning for this parcel;

thence continuing along the east line of Lot 14 and the west line of Potter Alley (12' wide) South 03 degrees 38 minutes 47 seconds West 7.50 feet to an iron pin set;

thence leaving the east line of Lot 14 and the west line of Potter Alley (12' wide) North 86 degrees 21 minutes 13 seconds West 22.00 feet to an iron pin set;

thence North 03 degrees 38 minutes 47 seconds East 19.50 feet to a mag-nail set on the south line of Bridge Alley (12' wide), also being the north line of Lot 14;

thence along the south line of Bridge Alley (12' wide), also being the north line of Lot 14 South 86 degrees 21 minutes 13 seconds East 10.00 feet to a mag-nail set;

thence leaving the south line of Bridge Alley (12' wide), also being the north line of Lot 14 South 03 degrees 38 minutes 47 seconds West 12.00 feet to a point;

thence South 86 degrees 21 minutes 13 seconds East 12.00 feet to the place of beginning containing 0.007 acres, more or less.
