Cochran property, said Point also being the Northwesterly Corner of the Travis Pittman property Recorded in Official Record Book 2707, Page 191, Recorder's Office, Muskingum County, Ohio;

Thence **SOUTH 03°40'06" WEST** a distance of **133.38 FT** along the Easterly Line of the Hal M. Cochran property, along the Westerly Line of the Travis Pittman property, passing a 4 Inch Diameter Axle at 17.61 FT to a 5/8" Iron Pin (Found), said Iron Pin (Found) being the Southeasterly Corner of the Hal M. Cochran property, said Iron Pin (Found) also being the Southwesterly Corner of the Travis Pittman property, said Iron Pin (Found) also being on the Northerly Line of the Greg L. and Becky A. Harrison property, along the Northerly Line of a Alley to a 1" Square Top Bolt (Found), said 1" Square Top Bolt (Found) being the Southwesterly Corner of the Hal M. Cochran property, said Iron Pin (Found) also being the Southeasterly Corner of the Theron J. and Courtney N. Edwards property;

Thence NORTH 03°28'54" EAST a distance of 134.35 FT along the Westerly Line of the Hal M. Cochran property, along the Easterly Line of the Theron J. and Courtney N. Edwards property, passing a 1" Square Top Bolt (Found) at 112.56 to the TRUE PLACE OF BEGINNING containing 0.2030 ACRES more or less, subject to all easements, restrictions, and rights-of-way or record.
