Beginning at a point in the Half Section Line and in the centerline of the Roseville & Cannelville Road and in the southeast corner of the T. K. & P. D. Miller, et al property (deed reference, Volume 818, page 182, of the Deed Records of said County);

Thence passing along the said centerline of the Roseville & Cannelville Road, the following bearings and distances:

South 16° 03' 30" West, 74.78 feet to a point;  
South 66° 38' West, 168.50 feet to a point;  
South 53° 36' 50" West, 138.66 feet to a point;  
South 50° 00' West, 842.79 feet to a point;  
South 52° 45' 20" West, 78.43 feet to a point; and

Containing 14.30 acres, more or less.




