Being a part of the Northeast Quarter of Section Ten (10), Township
Fourteen (14), Range Fourteen (14) of the Congress Lands east of the Scioto
River and part of property now owned by Martha Thompson and Recorded in
Deed Book 1062, Page 231 of the Muskingum County Deed Records bounded and
described as follows:

Commencing at a post at the northeast corner of said northeast quarter
of section 10, said post is referenced by an iron pin found 4.00' north
and an iron pin found 4.00' west from said post; thence $S.2^{\circ}43'10''W.$ (the
base of bearings for this description is state plane grid from a solar
observation) along the east line of said northeast quarter of section 10 a
distance of 759.87' to an old iron pin found surrounded by broken concrete
and described in previous descriptions as a concrete monument at the northeast
corner of the third parcel (Vol.946, Pg. 131) and owned by The Oxford Oil
Co.; thence $S.47^{\circ}59'02''W.$ along the north line of said Oxford Oil Co. and
the south line of property owned by Marcus Toth (Vol. 554, Pg. 5) a distance
of 1688.01' to an iron pin set on the northeasterly line of the grantor
herein and at the true place of beginning for the following described property;
thence along the easterly line of said grantor herein and along the westerly
line of a previous conveyance , Amanda Rider to Guy Rider (Vol.256,Pg. 107)
the following 2 courses and distances:

1- $S.67^{\circ}13'58''E.$ 74.50' to an iron pin set
2- $S.35^{\circ}19'58''E.$ 84.55' to a fiberglass fence post set in the center of
a small stream (Raiders Run) and passing through an iron pin set at 62.73' ;
thence $S.53^{\circ}16'41''W.$ 39.16' to a railroad spike set in the center of a bridge
for East Athens Road over said Raiders Run; thence $N.47^{\circ}59'21''W.$ along the
center of said East Athens Road 148.57' to an iron pin set; thence $N.47^{\circ}59'02''E.$
32.55' to the true place of beginning containing sixteen and no hundredths
(0.16) of an acre more or less.


